A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF LOXAHATCHEE GROVES, FLORIDA ACCEPTING AN EASEMENT FROM 1540 NORTH TREASURE DRIVE, LLC OVER A PORTION OF THEIR PROPERTY LOCATED AT 14563 NORTH ROAD, LOXAHATCHEE GROVES, FLORIDA; PROVIDING AN EFFECTIVE DATE.

WHEREAS, the Town Council of the Town of Loxahatchee Groves desires to obtain Easements for Roadway, Drainage, and Utility purposes; and

WHEREAS, specifically, the Town has received an easement from 1540 NORTH TREASURE DRIVE, LLC over a portion of their property 14563 North Road, Loxahatchee Groves, FL 33470.

WHEREAS, the Roadway, Drainage and Utility Easement is attached as Exhibit "A"; and

WHEREAS, pursuant to Section 05-085 of the Town's Unified Land Development Code and Town Council adopted procedures, all easements must be accepted by the Town Council prior to recording.

NOW THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF LOXAHATCHEE GROVES, FLORIDA, AS FOLLOWS:

- **Section 1.** The foregoing "Whereas" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.
- **Section 2.** The Town Council hereby accepts the Easement for Roadway, and/or Drainage and/or Utility purposes over a portion of the property located at 14563 North Road from the property owner(s) 1540 North Treasure Drive, LLC. Upon approval, the Mayor is authorized to execute the Easement on behalf of the Town, and Town staff is directed to have said Easement recorded in the public records.
- **Section 3.** All resolutions or parts of resolutions in conflict herewith are hereby repealed to the extent of such conflict.
- **Section 4.** If any clause, section, other part, or application of this Resolution is held by any court of competent jurisdiction to be unconstitutional or invalid, in part or application, it shall not affect the validity of the remaining portions or applications of this Resolution.
 - **Section 5.** This Resolution shall become effective upon its adoption.
