### Transportation Benefit District 2024 SUMMARY REPORT

The Transportation Benefit District (TBD) 2024 annual report is being provided to comply with RCW 36.73.160(2) which states that the “district shall issue an annual report, indicating the status of transportation improvement costs, transportation improvement expenditures, revenues, and construction schedules, to the public and to newspapers of record in the district.” The intent of this report is to provide information on 2024 planned and actual revenues and expenditures. It also discusses major actions affecting the Lynden TBD.

2024 was the second year of the renewed ten-year voter-approved TBD sales tax. Voters passed the renewal at the 2022 November General Election, and effective in 2023, authorized continuation of a sales and use tax of two tenths of one percent (0.002) to be collected from all taxable retail sales within the TBD in accordance with RCW 82.14.0455 for a term of ten years, or until such District is dissolved, whichever is earlier, for the purpose of paying or financing costs of necessary transportation improvement projects listed and identified in the City of Lynden Six-Year Transportation Improvement Plan.

#### 2024 Revenue

The 2024 Budget projected TBD Revenue of \$940,000. Lynden’s TBD sales tax revenues in 2024 fell short of budget projections by less than 1% as shown in the following table:

### Comments on 2024 Budget Execution:

1. Cedar Drive was delayed due to the extent of utility improvements identified during field investigation and design. There were also some right-of-way issues to resolve. This project was completed in 2024 within the engineer's estimate, including additional sidewalk at Depot Road and East Cedar Drive.
2. 1<sup>st</sup> Street Rehabilitation was completed under budget.
5. Judson / 9<sup>th</sup> LID Phase 2 began in 2024 after a delay due to extensive review by Department of Ecology. This project will be completed in 2025.
6. W Main Roundabout / Berthusen project has been delayed due to right-of-way acquisition, stormwater pond design, and Alliance Freeze Dry ownership transfer. This project is planned for 2026 construction.
