Hello David,

Your permits submitted to today's Council meeting were tabled until our next meeting on March 20th. It was mentioned that your proposed vehicle and trailer might be used at multiple locations, rather than just the Grand Hotel which was the only location listed on your applications. If you plan to use your vehicle and trailer at multiple locations, I need a list of all intended locations as each needs to be approved and paid for individually.

Further, the City Council would like reasoning from you as to why your materials and tools cannot be hauled by the dray (Mackinac Island Service Company) as vehicle and trailer permits cannot be approved on a convenience basis. It was noted that many roofing companies have completed large roofing jobs without vehicles in the past. It may be a good idea to contact the Mackinac Island Service Company to discuss the hauling of your tools and materials - they are able to haul trailers up to 3,000 pounds, and materials can also be loaded directly onto the dray. Trailers hauled by the dray service must be approved by the City Council as well, and are \$15.00 each. The Mackinac Island Service Company office number is (906) 847 - 3307 - I would recommend asking for Brad Chambers.

Please provide locations and reasoning for your permits by March 18, 2024 to ensure you are placed on the March 20th City Council agenda.
