The locations that we will need to cut sidewalk/asphalt are as follows

- 1. 7244 Main Street (Murdick's #2 nearest to Doud's). sidewalk directly in front.
- 2. 7337 Market Street Lilac House sidewalk directly across from the post office.
- 3. 7301 Main Street Benjamin Kodak sidewalk directly in front of store.
- 4. 7325 Main Street Coal Dock asphalt cut (directly in front of Seabiscuit alleyway beside the electrical pole).
- 5. 7340 Main Street sidewalk cut directly in front of Corby store.
- 6. 7367 Main Street sidewalk directly in front of where old Mr. B's Tastee Freeze was located.
- 7. 7463 Market Street Carousel Mall sidewalk directly in front of location.
- 8. 1294 Bourisaw Lane sidewalk smash directly in front of Jamie Bynoe's.
- 9. 7389 Market Street (Yankee Rebel Apartments) sidewalk directly in front of Lucky Bean.
- 10. 7810 Main Street Old Mcgreevy Cottage (Sidewalk in front of address on Mahoney).
- 11. 7447 Market Street Cindy Riding Stable (sidewalk directly in front of Cindy's).

The area of work is roughly from the intersection of Mahoney and M-185, Bourisaw Lane, Market Street and sidewalk locations stationed downtown.
