- The San Joaquin Valley Joint Powers Authority (SJJPA) invites the public to an open house meeting for the Madera High-Speed Rail (HSR) Station Full-Build Project Phase 3. The purpose of this meeting is to provide information regarding the Draft Environmental Impact Report (EIR) and to respond to general questions about the environmental analysis.

The meeting will include a presentation and informational boards summarizing the Project and the Draft EIR. SJJPA staff will be available to answer questions of a general nature.

- Tony Tavares, Director of the California Department of Transportation (Caltrans) will be retiring May 7, 2025.

11-B. Items from Caltrans

Jim Perrault, Caltrans District 06 provided the following comments:

- Michael Navarro is the new Director of Caltrans District 06, Shane Gunn has been appointed as the Interim Planning Director.
- The Madera South Expressway project, FHWA informed Caltrans that the \$25 million in RURAL grant funds were at risk. Through collaboration between FHWA, Caltrans, and the County of Madera, the funds were successfully obligated.
- The Caltrans Sustainable Planning Grant application was due January 22, 2025. District 06 received a grant application from Madera County Transportation Commission for a Climate Adaptation Planning Grant. The grant awards will be announced mid to late summer.
- The State Route 99 Comprehensive Multimodal Corridor Plan (CMCP) is set for completion by June 30, 2025. With public workshops now concluded, the draft will

be available by April 30 for public review and was presented at the San Joaquin Valley Regional Policy Conference.

- The South Madera Six Lane project, Avenue 7 to Avenue 12, is in the process of addressing right-of-way issues with property owners. The right of way certification has been moved to October 1, 2025.
- The North Madera Six Lane project, Avenue 17-22 project environmental process has begun. The environmental review process is expected to take two years, targeted completion is April 2028. The contract to bid for construction is expected to begin in November 2030.
- The Downtown Madera Capital Preventative Maintenance project utility certification is expected in June 2025. Construction anticipated to begin early 2026.
- The State Route 99/233 Interchange Improvement project 60% constructability review meeting is targeted for June 2025. Project ready to list for construction in summer 2026.
- Cottonwood Creek Bridge Replacement project northbound offramp is open to the public. Construction is anticipated to be completed June 2025.
- The Madera Ranchos Rehabilitation project between Avenue 15 and State Route 145 project is open to traffic. Project completion is anticipated in April 2025.
- The Chowchilla Capital Preventative Maintenance project includes Class II bike lanes, ADA ramps, bulb-outs, enhanced visibility crosswalks, sidewalks, and flashing beacons. The Project Report was approved September 2024, the PS&E right of way phases are underway, and ready to list November 2026.
- During the March meeting, Supervisor Macaulay posed questions to Caltrans, which were subsequently answered via email.
