**SUMMARY:**

The Madera County Transportation Commission is a designated recipient of Low Carbon Transit Operations Program funds for the Madera region.

The Low Carbon Transportation Operations Program (LCTOP) is one of several programs that are part of the Transit, Affordable Housing, and Sustainable Communities Program established by the California Legislature in 2014 by Senate Bill 862. The LCTOP was created as a statewide program to provide operating and capital assistance for transit agencies to reduce greenhouse gas emissions and improve mobility, with priority on serving disadvantaged communities. This program is funded by auction proceeds from the California Air Resource Board's Cap-and-Trade Program established by Assembly Bill 32 with proceeds deposited into the Greenhouse Gas Reduction Fund.

The City of Madera has proposed a Corrective Action Plan to amend LCTOP allocations for FY 2017-18, 2018-19, 2019-20, and 2022-23.
