11. MISCELLANEOUS

11-A. Items from Staff

Patricia Taylor, Executive Director, provided the following Comments:

- Director Taylor distributed to Board Members the "Highway 99: The Lifeline of Safety and Commerce" brochure. The brochure underscores the importance of consistent advocacy efforts. Providing this material to legislators is a valuable step in communicating the regional transportation priorities and needs of the three counties.
- Director Taylor informed the policy board that there will not be a MCTC/MCTA Policy Board meeting in June 2025.

11-B. Items from Caltrans

Shane Gunn, Caltrans District 06 provided the following comments:



- Caleb Brock, Office Chief, has left to act as Deputy Director District Planning in District 10, currently advertising for a temporary backfill.
- Director Tavares has left, and Chief Deputy Director Mike Keever has been appointed as the acting Caltrans Director.
- The Chowchilla SR 233 Enhancement project is ongoing. The City requested adding a gateway monument to the project but is also being explored in another capital project. The anticipated completion is summer 2025.
- The Caltrans Sustainable Transportation Planning Grant awards are expected to be announced in June.
- The Trade Corridor Enhancement Program and Local Partnership Program awards are expected to be announced late May or early June 2025, with adoption by CTC scheduled for the June meeting.
- Notice of Funding Opportunity for the Regional Infrastructure Accelerators Program.
 The program funds technical resources, planning, and project development to expedite regional transportation infrastructure through innovative financing and delivery methods, including public-private partnerships. The application deadline is June 16, 2025. Letters of support requests from Caltrans can be directed to Caltrans staff.
- Safe Streets and Roads for All application deadline is June 26, 2025. Letters of support at the District level are available, requests can be directed to Caltrans staff.
- South Madera Six Lane project is being combined with South Madera Rehab SHOPP Project. Completion of PS&E is October 2025. Caltrans is addressing right-of-way issues with property owners determining property requirements. Construction is scheduled for Summary 2026.
- Caltrans, has been working with the County of Madera on the Zero Emission Vehicles (ZEV) charging stations as part of greenhouse gas mitigation. The most viable locations are being identified.
- The North Madera Six Lane project, Avenue 17-22, project Environmental phase is now underway. PA&ED is targeting April of 2028. The project is anticipated to be ready to list November of 2030. Caltrans will be hosting a 'virtual' and 'in person' Public Scoping Meeting in August 2025.
- The Downtown Madera Capital Preventative Maintenance project PG&E relocation is no longer necessary. Union Pacific Railroad issued the Maintenance Consent Letter. The project will be ready to list June 2025. Construction is targeted to begin January 2026.
- The State Route 99/233 Interchange Improvement project 60% constructability review meeting is targeted for June 2025.



- The Cottonwood Creek Bridge Replacement project construction is anticipated to be completed by June 2025.
- The Madera Ranchos Rehabilitation project between Avenue 15 and State Route 145 is open to traffic. Project completion is anticipated in May 2025.
- Chowchilla Capital Preventative Maintenance project 60% Constructability Review was held on April 1, 2025. The PS&E and right of way phases are underway, and ready to list Spring 2026.
