### AMENDMENT TO PROFESSIONAL SERVICES AGREEMENT

This Amendment to Professional Services Agreement ("Amendment") is made and entered into by and between the City of Madison, Alabama, a municipal corporation, located at 100 Hughes Road, Madison, Alabama 35758, hereinafter referred to as the "City," and OMI, Inc., located at 5151 Research Drive, N.W., Suite A, Huntsville, Alabama 35805, hereinafter referred to as "Consultant."

## **RECITALS:**

WHEREAS, by virtue of the passage of Resolution Number 2024-356-R, the City Council of the City of Madison, Alabama, authorized the City's entry into a Professional Services Agreement ("Agreement") with Consultant for twenty-nine thousand five hundred sixty-seven dollars (\$29,567.00) for professional engineering services for inclinometer installation and periodic monitoring of slope stability for the Hughes Road southeast bridge slope; and

WHEREAS, the Agreement became effective on November 14, 2024; and

**WHEREAS,** Section 1 (A) of said Agreement outlined the services to be provided by Consultant and specified that all services shall be done in accordance with the proposal submitted by Consultant, said document being referred to in the original Agreement as "Attachment A" and being included therein and made a part thereof by reference; and

WHEREAS, Consultant has submitted an addendum proposal at the request of the City's Engineering Department to install a fourth inclinometer and provide monitoring along with the other three inclinometers; and

**WHEREAS**, the City must approve any modification to Consultant's scope of work and the specified budget for said work; and

**NOW, THEREFORE,** in consideration of the foregoing premises and the parties' respective agreements, promises, representations, and warranties contained herein, City and Consultant agree as follows:

## A. Amendment to Professional Services Agreement.

Section 1(A) of the Agreement is amended by the addition of a new Section 1(A1) as follows:

Pursuant to the provisions of this Agreement, Consultant will provide the following additional services to City: See Consultant's proposal dated March 17, 2025, which is labeled as "Attachment B, Addendum to Proposal for Additional Inclinometer Installation and Periodic Monitoring of Slope Stability at Hughes Road Railroad Overpass Embankment," (the "Scope of Additional Services") and is wholly incorporated herein by

this reference.

# B. Fee for Additional Services.

Pursuant to Section 2(E) of the Agreement and the Scope of Additional Services, the compensation for additional services rendered by Consultant shall not exceed **fifteen thousand eight hundred seventy-seven dollars (\$15,877.00)**. The total contract value pursuant to Section 2(A) now shall not exceed forty five thousand four hundred forty four dollars (\$45,444.00).

### C. Remainder.

Unless specifically amended herein, all other provisions, attachments, content, language, recitals, covenants, promises, guarantees, and commitments contained in, referenced in, or incorporated into the original Professional Services Agreement remain valid and in full force and effect.

#### D. Effective Date.

The foregoing Amendment shall come into effect when the authorized representatives of each party finally execute and affix their respective signatures hereto in their duly authorized capacities. In the event the signatures are affixed on different dates, the date of the final signature shall be the date that this Amendment comes into effect.
