

AMENDMENT TO PROFESSIONAL SERVICES AGREEMENT

This Amendment to Professional Services Agreement ("Amendment") is made and entered into by and between the City of Madison, Alabama, a municipal corporation, located at 100 Hughes Road, Madison, Alabama 35758, hereinafter referred to as the "City," and Orchard, Hiltz, & McCliment, Inc. (d/b/a OHM Advisors), Inc., located at 209 10th Avenue South, Suite 154, Nashville, TN 37203, hereinafter referred to as "Consultant."

RECITALS:

WHEREAS, by virtue of the passage of Resolution Number 2025-186-R, the City Council of the City of Madison, Alabama, authorized the City's entry into a Professional Services Agreement ("Agreement") with Consultant for two hundred forty thousand dollars (\$240,000.00) for professional surveying and design services for the proposed project extending Garner Street to Madison Boulevard; and

WHEREAS, the Agreement became effective on June 25, 2025; and

WHEREAS, Section 1(A) of said Agreement outlined the services to be provided by Consultant and specified that all services shall be done in accordance with the proposal submitted by Consultant, said document being referred to in the original Agreement as "Attachment A" and being included therein and made a part thereof by reference; and

WHEREAS, Consultant has submitted an addendum proposal at the request of the City's Engineering Department to provide design services for water main facilities along the Garner Street, Phase 3 extension; and

WHEREAS, the City must approve any modification to Consultant's scope of work and the specified budget for said work; and

NOW, THEREFORE, in consideration of the foregoing premises and the parties' respective agreements, promises, representations, and warranties contained herein, City and Consultant agree as follows:

A. Amendment to Professional Services Agreement.

Section 1(A) of the Agreement is amended by the addition of a new Section 1(A1) as follows:

Pursuant to the provisions of this Agreement, Consultant will provide the following additional services to City: *See Consultant's proposal dated August 25, 2025, which is labeled as "Attachment B, Garner St. Extension to Madison Blvd., Amendment 1 – Water Main Extension," (the "Scope of Additional Services") and is wholly incorporated herein by this reference.*

B. Fee for Additional Services.

Pursuant to Section 2(E) of the Agreement and the Scope of Additional Services, the compensation for additional services rendered by Consultant shall not exceed **ten thousand dollars (\$10,000.00)**. The total contract value pursuant to Section 2(A) now shall not exceed two hundred fifty thousand dollars (\$250,000.00).

C. Remainder.

Unless specifically amended herein, all other provisions, attachments, content, language, recitals, covenants, promises, guarantees, and commitments contained in, referenced in, or incorporated into the original Professional Services Agreement remain valid and in full force and effect.

D. Effective Date.

The foregoing Amendment shall come into effect when the authorized representatives of each party finally execute and affix their respective signatures hereto in their duly authorized capacities. In the event the signatures are affixed on different dates, the date of the final signature shall be the date that this Amendment comes into effect.

IN WITNESS WHEREOF, the parties hereto affirm that they have the authority to execute this Amendment on behalf of their respective entities for the entire term and have hereunto set their hands and seals on the day and year respectively noted.
