REDACTION STUDIO

The redaction process begins in Redaction Studio. Hosted within Axon Evidence, users can manually redact video and audio files using a collection of redaction tools. This seamless integration allows for cohesive management of evidence files and a secure chain of custody from within a single platform.

MANUAL MASKING & AUTO-TRACKING

Use Object Tracker to manually apply masks that automatically follow the assigned object throughout the video.

MASK DELETION RECOVERY

Should a mask be accidentally deleted, simply undo or redo that specific action, keeping the integrity of the various steps of your redaction process.



CUSTOM EXEMPTION CODES

Create your own custom drop-down list of exemption codes to simplify assignment and tracking of masks. The exemption log is automatically attached to the redacted file, speeding up the response process.

MULTIPLE AUDIO STREAM MANAGEMENT

Select, view, and listen to a specific audio stream in a video file that identifies multiple audio streams.

MASK VIEWING & NAVIGATION

The Redacted Objects Panel makes it easy to see all redactions and quickly jump to a specific moment in the video that a mask was applied. Any masks with missing exemption codes will be flagged so you can stay on top of your redaction reasonings.

Redaction Assistant includes additional Al tools that enhance workflow efficiency within Redaction Studio.

SCREEN, HEAD, & LICENSE PLATE AUTO-MASKING

Apply AI models purpose-built for law enforcement to efficiently redact screens, heads, and license plates throughout every frame in the video.

AUDIO REDACTION ACCELERATION VIA TRANSCRIPT

Leverage audio redact via transcript by simply searching for or clicking any words found inside the transcript to auto-redact them throughout the entire video.

CONSTANT PROCESSING TIME

Any video up to 2 hours in duration is processed by AI in 10 minutes or less.

HEAD MASKING & TRACKING

All unique heads are identified and followed throughout the video, even as they move in and out of frame; quickly select which to redact via a new thumbnail panel.

Activate Redaction Assistant on up to 20 pieces of video evidence simultaneously from the evidence search page or within cases to bulk redact screens, heads, and license plates.
