REPORTS

6. Police Report by the Chief of Police

Chief Taylor stated for the month of May they had 543 calls for service out of those calls they had 27 911 transfers, 1 abandoned vehicle, 1 accident no injury, 1 accident unknown injury, 4 business alarms, 31 animal calls, 10 BOLO's , 2 breaking and entering, 3 disturbances, 1 domestic, 2 different EMS calls, Taylor stated there was actually way more EMS calls but for some reason they did not show, 1 escort, 4 different fire calls, 29 follow ups, 15 foot patrols, 273 calls for information, 2 emergency mental detentions, 3 missing persons he stated that really weren't missing, 3 open doors, 4 reckless drivers, 23 requests to speak with an officer, 1 shots fired, 2 stolen property, 1 stolen vehicle, 8 suspicious persons, 4 suspicious vehicles, 2 trespassing, 6 welfare checks. Out of all of that there were 26 reports breaking down to 2 aggravated assaults, 3 simple assaults, 1 bribery, 3 burglaries, 6 different types of frauds, and some trespassing.

7. Fire Report by the Fire Chief

Chief Gambill stated they had a total of 26 calls that generated run reports breaking down to 2 gas leaks, 6 lift assists, 3 helicopter landing zones, 3 structure fires, 7 grass fires, 2 motor vehicles accidents, 1 leaking hydrant, 1 burning in city limits, and 1 power outage. He stated they conducted a controlled burn at the city landfill. Total hours on these calls were 64 hours that did not include any in house training that they did or the hydrant flushing that they are currently working on.
