  - (a) To Customer: Written notices to Customer required under the Agreement shall be sent via i) hardcopy to the Customer address specified on the signature page, or any change thereto provided to TruBridge in writing; or ii) electronically to a valid electronic mail address of an authorized representative of Customer.
  - (b) To TruBridge: Written notices to TruBridge required under the Agreement shall be sent electronically to <u>legal@trubridge.com</u> followed by hardcopy to the attention of the <u>Legal</u> <u>Department</u> at the TruBridge address specified on the signature page, or any change thereto provided to Customer in writing.
- 4. **Inclusion in Agreement:** It is expressly understood and agreed that this Addendum and the Exhibit(s) A attached hereto are hereby incorporated into the Agreement by reference.
- 5. **Entire Addendum:** This Addendum, to include Exhibit A, sets forth the entire understanding of the parties hereto with respect to the subject matter contained herein and supersedes all other oral or written representations with respect to the same.

## Service: Software Subscription – Quality Measures Intelligence – SDOH

### A. Services and Fees:

- 1. Services: The Software Subscription will include:

  - Configuration and implementation of the Service Software.
