

RESOLUTION NO. 2026-02

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MANOR, TEXAS EXPRESSING SUPPORT FOR THE TRAVIS COUNTY SPONSORED APPLICATIONS TO THE CAPITAL AREA METROPOLITAN PLANNING ORGANIZATION'S 2028 – 2031 CALL FOR PROJECTS; AND DECLARING AN EFFECTIVE DATE.

WHEREAS, the Capital Area Metropolitan Planning Organization (CAMPO) is the regional transportation planning organization for the area that includes Bastrop, Burnet, Caldwell, Hays, Travis, and Williamson Counties; and

WHEREAS, CAMPO issued a call for projects in October 2025 for eligible sponsors to apply for federal funding assistance through the Surface Transportation Block Grant (STBG), the Transportation Alternatives Set-Aside (TASA), and the Carbon Reduction Program (CRP) funding programs; and

WHEREAS, federal funding may be used for development and implementation of transportation projects that serve the six-county CAMPO region; and

WHEREAS, Travis County will sponsor and provide the required local match for the Howard Lane East, Wells Branch Parkway Phase IV and Taylor Lane/Parsons Road/Kimbro Road Corridor Plans that are partially located within the jurisdiction of the City of Manor, and these Corridor Plans will result in a conceptual schematic of the preferred alternative for each Plan; and

WHEREAS, Travis County would be responsible for all non-reimbursable costs and 100% of overruns, if any, for County sponsored Corridor Plans that are awarded funding; and

WHEREAS, the City Council of Manor, Texas (the “City Council”) believes that the Howard Lane East, Wells Branch Parkway Phase IV and Taylor Lane/Parsons Road/Kimbro Road Corridor Plans will be beneficial to improving transportation safety, mobility and accessibility within the jurisdictional boundaries of Manor, Texas.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MANOR, TEXAS, THAT:

Section 1. The City Council hereby approves the recitals contained in the preamble of this Resolution and finds that all the recitals are true and correct and incorporate the same in the body of this Resolution as findings of fact.

Section 2. The City Council hereby approves and concurs with the following Corridor Plans as described in the applications for the 2028 – 2031 CAMPO Call for Projects as shown in the exhibit assigned and attached hereto:

Section 3. It is hereby declared the intention of the City Council to commit to working with Travis County on the Corridor Plans development, financing, management, approval, and implementation of the completed planning documents, should the Corridor Plans be selected for funding.




