### AGENDA ITEM DESCRIPTION:

Consideration, discussion, and possible action on a Resolution Expressing Support for the Travis County Sponsored Applications to the Capital Area Metropolitan Planning Organization's 2028 – 2031 Call for Projects.

### BACKGROUND/SUMMARY:

The Capital Area Metropolitan Planning Organization has issued a call for regional transportation projects for the communities in Bastrop, Burnet, Caldwell, Hays, Travis, and Williamson Counties. CAMPO issued a call for projects in back in October 2025 for eligible communities to apply for federal funding assistance through the Surface Transportation Block Grant (STBG), the Transportation Alternatives Set-Aside (TASA), and the Carbon Reduction Program (CRP) funding programs. Travis County has requested the City of Manor to support the following projects:

- Howard Lane East extension project,
- Wells Branch Parkway Phase IV, and
- Taylor Lane/Parsons Road/Kimbro Road corridor project as shown in the attachments.

The city will request a resolution of support for the following roadway projects that need improvement to handle the community's population growth since 2014. The City of Manor ranked 6<sup>th</sup> in the nation for growth projection from 2014-2024 at 217%. With that level of growth during a 10 year span, public roads and other public infrastructure need to be addressed as soon as possible. In order to address local and regional transportation needs in a strategic and collaborative manner, communities need to plan and actively participate in CAMPO and CAPCOG that improves the region's overall quality of life and business environment for companies to expand and relocate to Central Texas. The roads and corridor improvements that the City of Manor is submitting are necessary and justifiable since the city has never had any projects included on previous CAMPO Regional Transportation Plans:

- Johnson Road from FM973 to Bois D Arc
- Tower/Suncrest from FM973 to Bois D Arc
- Gregg Lane from FM973 to Fuchs Grove
- Old Kimbro from US290 to Old Hwy 20
- Bridge/roadway from 290/Shadow Glen to Old Hwy 20
- Widening of Old Highway 20 bridge over Wilbarger
