With a quorum of the Council Members present, the regular session of the Manor City Council was called to order by Mayor Harvey at 7:04 p.m. on Wednesday, July 6, 2022, in the Council Chambers of the Manor City Hall, 105 E. Eggleston St., Manor, Texas.

The city staff recommended that the City Council approve the Statement of Work #16 to the existing Master Services Agreement with George Butler Associates, Inc. for the Cottonwood Creek Wastewater Treatment Plant, Phase II expansion project in the amount of \$372,300.00.

City Engineer Phelan discussed the proposed project for Cottonwood Creek Wastewater Treatment Plant, Phase II expansion.

Discussion was held on other potential projects that could possibly be built in the area.

Discussion was held regarding the funding for the project.

City Manager Moore suggested for a Capital Improvement Committee meeting to be conducted for capital project discussion.

**MOTION:** Upon a motion made by Council Member Deja Hill and seconded by Council Member Weir, to approve the Statement of Work #16 to the existing Master Services Agreement with George Butler Associates, Inc. for the Cottonwood Creek Wastewater Treatment Plant, Phase II expansion project in the amount of \$372,300.00.

Council Member Deja Hill inquired if the Capital Improvement Committee meeting would be in conjunction with the P&Z Commission. City Engineer Phelan stated that the meeting was only for the Capital Improvement Committee at this time.

The city staff recommended that the City Council approve a request for outdoor athletic field lighting for the Manor ISD Athletic Field Complex at 14832 N. FM 973.

Development Services Director Dunlop discussed the proposed outdoor lighting for the athletic field complex for the Manor ISD Senior High School.

**MOTION:** Upon a motion made by Council Member Wallace and seconded by Council Member Amezcua, to approve a request for outdoor athletic field lighting for the Manor ISD Athletic Field Complex at 14832 N. FM 973.

Mayor Harvey inquired about the conclusion of games, if exceeded the 10:00 p.m. cutoff time.

Development Services Director Dunlop clarified that the lights would stay on if there was an active game or until everyone had exited the field. He also stated that the parking lot lighting would stay on through the night for safety concerns.

Council Member Moreno volunteered to be removed form the Public Tree Advisory Board.

City Secretary Almaraz clarified that the Park Committee and Public Tree Advisory Board had the same members and if Council was volunteering to be removed from one, they would automatically be removed from the other.

City Secretary Almaraz reminded Council that the new appointment would be for an unexpired term and that new committee appointments would be conducted after the November 2022 General Election.

Council Member Weir volunteered to be removed from the Budget Committee.

**MOTION:** Upon a motion made by Council Member Amezcua and seconded by Mayor Pro Tem Emily Hill to remove Council Member Weir from the Budget Committee and appoint Council Member Deja Hill to the unexpired term on the Budget Committee.

There was no further discussion.
