

RESOLUTION NO. 2025-40

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MANOR, TEXAS SUPPORTING THE CITY OF MANOR'S SUBMISSION OF A TEXAS INTERNSHIP INITIATIVE GRANT APPLICATION; AUTHORIZING THE CITY MANAGER TO EXECUTE ALL NECESSARY DOCUMENTATION; AND ESTABLISHING AN EFFECTIVE DATE.

WHEREAS, the Texas Workforce Commission is offering funding under the Texas Internship Initiative (TII) to expand paid, work-based learning opportunities to prepare students, recent graduates, and military-related interns for middle-skill STEM careers and to strengthen local workforce pipelines; and

WHEREAS, the City of Manor, Texas ("City") supports advancing manufacturing, IT, energy, life sciences and other industries targeted by the TII to strengthen the City's workforce pipeline; and

WHEREAS, the City Council of the City of Manor, Texas (the "City Council") finds that supporting the submission of the TII grant application has the potential of empowering local students and veterans, strengthening local businesses through skilled talent and driving long-term economic prosperity for the community if awarded a TII grant; and

WHEREAS, the City Council of the City of Manor, Texas (the "City Council") has determined that it is in the best interest of the City to submit a TII grant application.

NOW THEREFORE BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MANOR, TEXAS:

Section 1. The City Council hereby approves the recitals contained in the preamble of this Resolution and finds that all the recitals are true and correct and incorporate the same in the body of this Resolution as findings of fact.

Section 2. The City Council hereby supports the submission of a Texas Internship Initiative grant application.

Section 3. The City Council hereby authorizes the City Manager to execute all necessary documentation regarding this grant.

Section 4. If any section, article, paragraph, sentence, clause, phrase or word in this resolution or application thereof to any persons or circumstances is held invalid or unconstitutional by a court of competent jurisdiction, such holding shall not affect the validity of the remaining portions of this resolution; and the City Council hereby declares it would have passed such remaining portions of the resolution despite such invalidity, which remaining portions shall remain in full force and effect.

Section 5. This resolution shall take effect immediately from and after its passage, and it is duly resolved.
