With a quorum of the Council Members present, the regular session of the Manor City Council was called to order by Mayor Harvey at 7:04 p.m. on Wednesday, September 17, 2025, in the Council Chambers of the Manor City Hall, 105 E. Eggleston St., Manor, Texas.

Mayor Harvey led the Pledge of Allegiance.

Development Services Director Burrell discussed the proposed Concept Plan.

Economic Development Director Jones discussed the annexation of the property to the city and his negotiations with the developer to preserve the property's historical significance while creating new jobs.

Mayor Harvey discussed the property's annexation process and its potential benefits for the city, including job creation and property preservation. The aim was to reintegrate Manor Downs within the city limits.

City Manager Moore provided further details on the city's benefits and future regarding the proposed development.

A discussion was held regarding the procedures and ordinances regarding tree regulations for the developer.

A discussion took place concerning the integrity of the buildings.

Chief Phipps explained the process regarding the funding and clarified how the financing was approved for the years 2023-2024.

A discussion was held about the cybersecurity software and the regulations currently in place for the city.

A discussion took place to clarify that a budget amendment could be presented at a later date if the council wishes to review positions.

A discussion took place about future expenses for new facilities, maintenance and positions that will need to be included in the budget.

Mayor Harvey requested that staff provide future revenue funding projections in the budget proposal.
