Title: Ordinance No. 471 Updating District's Cross Connection Code

RECOMMENDATION: Adopt proposed Ordinance No. 471 to update the District's cross-connection code to reflect recent regulatory changes

SUMMARY: In 2023, the State repealed sections of Title 17 of the California Code of Regulations relating to cross-connection and replaced those sections with the State Water Resource Control Board's (State Board) *Cross-Connection Control Policy Handbook* (Handbook). In line with the Handbook, the District submitted a *Cross-Connection Control Plan* (Plan) to the State Board for review and approval. Marin Water's Plan was approved in July 2025. To appropriately reflect these changes, Chapter 11.14 of the District's Code related to cross connections must be updated to include appropriate and accurate references to the new requirements. Proposed Ordinance No. 471 adopts the new regulations by reference as opposed to repeating the detailed regulations as code.

DISCUSSION: At the December 9th Board of Directors meeting, staff brought an item to provide updates to the changed requirements of the District's Cross-Connection Control Program, as well as the State Board's approval of the District's Cross-Connection Control Plan on July 10, 2025.

The new requirements in the Handbook and the District Plan need to be updated in the District's Code. Staff is recommending that the Board adopt the new requirements by reference in the District Code, rather than inclusion of the full text of the Handbook and the Plan. The reference in the District Code available through the District's website will be able to incorporate a link to these documents for ease of access to those seeking this information. The incorporation by reference will also indicate the intent to incorporate future amendments to the Handbook and the Plan thereby automatically ensuring ongoing compliance with the State Handbook and District Plan as they may change over time.

With the repeal of Title 17 of the California Code of Regulations, some references in Marin Municipal Water District's Code, Chapter 11.14 entitled "Cross-Connections" must be updated to remove

repealed references. To ensure compliance with the new Handbook and Plan requirements, staff is proposing the changes summarized in the table below.
