1. **RENEWAL TERM** This Lease shall be renewed for a period of <u>one (1) year</u>, commencing <u>March 1, 2019 and continuing through February 29, 2020</u> ("Renewal Term"), at the same terms, conditions and rental rate.

2. <u>RENT</u>

- 2.1 As rent for the Leased Premises and in consideration for all covenants, representations and conditions of this Lease, LESSEE agrees to pay the LESSOR a rent rate of <u>one</u> <u>hundred twenty five and no/100 dollars (\$125.00)</u> per month, resulting in a total amount not to exceed <u>one thousand five hundred and no/100 dollars (\$1,500.00)</u> per year, due and payable monthly on the last day of each month.
- 3. Except as modified by the provisions of this Amendment, said Lease is ratified and confirmed as originally written.
