Subject:	Project Z74: Huron Road/Superior Road Reconstruction Project - Consider Resolution Accepting Bid.
Background Information:	<p>Bids were received on April 18, 2019 for the above-referenced project. R&G Construction Co. of Marshall, Minnesota, was the lowest responsible bidder as shown on the attached resolution. Attached is a map showing the project area.</p> <p>MMU has reviewed the bids and has concurred with a recommendation to award the contract to R&G Construction Co. MMU will be responsible for all watermain, services up to and including the curb stop/valve, and all base and surfacing costs above these items.</p> <p>Attached is the "Resolution Accepting Bid" awarding the contract to R&G Construction Co. of Marshall, Minnesota in the amount of \$787,018.00.</p>
Fiscal Impact:	The estimated total project cost including 5% allowance for contingencies and 16% for engineering and administrative costs is \$958,587.92 funded from Account #260-60211-5570. The engineer's estimate for the project was approximately 1,038,800.00.
Alternative/ Variations:	No alternative actions recommended.
