Subject:	Consider Resolution for Removal of Signage on McLaughlin Drive
Background Information:	<p>City staff received a request from SMSU regarding changing the parking restrictions on McLaughlin Drive behind the SMSU Foundation apartments indicating SMSU have been receiving complaints from the students on the lack of parking available near the apartments.</p> <p>City staff has reviewed this request, and McLaughlin Drive has been signed for “no parking” between 2 a.m. and 6 a.m. since 1993. City staff do not view this parking restriction as a necessity today. Snow removal typically occurs in this area outside of 2-6 a.m., so there is no real benefit to the City for the parking restriction.</p>
Fiscal Impact:	Staff time.
Alternative/ Variations:	No alternative actions recommended.
Recommendations:	that the Council adopt Resolution 25-070, which is the “Resolution Revoking Resolution 1557, Second Series and Authorizing the Removal of “No Parking” Signage on McLaughlin Drive”.

**RESOLUTION REVOKING RESOLUTION 1557, SECOND SERIES
AND
AUTHORIZING THE REMOVAL OF “NO PARKING” SIGNAGE ON MCLAUGHLIN DRIVE**

WHEREAS, City Code Sec. 74-26 provides for traffic control devices and markings;

AND WHEREAS, Sec. 74-26 of the City Code states:

“No device, sign or signal shall be erected or maintained for traffic or parking control unless the council shall first have approved and directed the same, except as otherwise provided in this section;”

AND WHEREAS, Resolution Number 1557, Second Series was adopted 04/05/1993, which authorized the installation of signage restricting parking on the north and south side of McLaughlin Drive from State Street East from 2AM to 6AM;

AND WHEREAS, it has been determined that the City no longer requires parking restriction on McLaughlin Drive;

NOW THEREFORE BE IT RESOLVED BY THE COMMON COUNCIL OF THE CITY OF MARSHALL, MINNESOTA:

1. That Resolution Number 1557, Second Series adopted 04/05/1993 be revoked.
2. That the Public Works Division remove the “No Parking from 2AM to 6AM” signs on the north and south side of McLaughlin Drive from Mustang Trail to O’Connell Street.
