This charter amendment would amend Section 3.3(A) of the Charter to change the Candidate Qualifying Period to the first full week in December instead of the first two full weeks in December. Should the Charter be amended?

If the voters approve the charter amendment at the March 19, 2024 Municipal Election, it will take effect for the candidate qualifying period beginning in December 2024 for the March 2025 Municipal Election.

There will not be a race for Commissioner District 1 and Commissioner District 2 on the March 19, 2024 Municipal Ballot. Incumbents David Tagliarini (Commissioner District 1) and Ray Kerr (Commissioner District 2) were the only candidates who qualified during the qualifying period in December 2023 to have their names placed on the March 19, 2024 Municipal Election Ballot. No one else applied during the qualifying period. They will be sworn into office at a Special Board of Commissioners meeting on Wednesday, March 27, 2024 at 5:30 p.m., to begin a new two-year term as District Commissioner. A light reception begins at 4:30 p.m. in the Commission Chambers. The Board of Commissioners Regular Workshop Meeting is at 6:00 p.m.

# MAJOR EVEN**TS**. MADEIRA BEACH

1848 Hurrican that lashed Tampa Bay made a cut through the existing islands forming "John's Pass". John's Pass was named after John Lewick, an early pioneer who used the area to catch sea turtles. 1913 A realtor named Walter Fuller bought Treasure Island for \$800.00. He formed a development company and sold shares for \$1,000.00. Albert Archibald contined with development until he owned most of Treasure Island. Later he formed the Madeira Holding Company. 1927 Welch Causeway and bridge built (now known as Tom Stuart Causeway, Madeira Beach Causeway and 150th Avenue. John"s Pass bridge built. 1927 ● E.C.Brandon named Madeira Beach first City Manager. 1953 Sanitary sewer system and treatment plant put into operation. 1953 1955 Police Department installed their own radio station, dispatching their own units. The station was based in Madeira Beach City Hall where the Police and Fire Departments were located, 14509 Gulf Blvd. 1961 ▶ Started construction on 4-laning 150th Avenue and new Madeira Causeway bridge. 1964 Construction of new Madeira Beach City Hall including facilities for Police and Fire also land for future development of recreational facilities. 1957 Completion of Madeira Beach Shopping Center (Publix

Market).
