AN ORDINANCE OF THE CITY OF MADEIRA BEACH, FLORIDA, AMENDING SECTION 2-151, OF THE CODE OF ORDINANCES TO AMEND THE TITLES OF ADMINISTRATIVE DEPARTMENTS OF THE CITY OF MADEIRA BEACH; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, City Charter, Section 5.6, *Administrative departments*, the Board of Commissioners may establish or abolish departments of the City, offices or agencies pursuant to the authority granted by ARTICLE IV, BOARD OF COMMISSIONERS, Section 4.7, Creation of New Departments, of the Charter; and

**WHEREAS**, the Board of Commissioners has determined that it is appropriate to change the names of certain departments within the City.

## NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF THE CITY OF MADEIRA BEACH, FLORIDA:

- Section 1. That Section 2-151 of the Code of Ordinances of the City of Madeira Beach, Florida, shall be amended to read as follows:
  - (a) The administrative departments of the city shall be as follows:
    - 1. City manager/administration department
    - 2. Finance department
    - 3. Community development department
    - 4. Fire department
    - 5. Information Technology (IT)
    - 6. Public Works
    - 7. Recreation
    - 8. Marina
    - 9. Human Resources
    - 10. City Clerk
  - (b) The duties of the City Manager and the department heads shall be those assigned in the Charter and in other parts of the Code of Ordinances.
- **Section 2.** That this Ordinance shall take effect immediately upon its adoption.

Persons who wish to appeal any decision made by the Board of Commissioners with respect to any matter considered during a public hearing at this meeting will need a record of the proceedings, and for such purpose may need to ensure that verbatim record of the proceedings is made, which record includes the testimony and evidence upon which the appeal is based. It is the responsibility of the person making the appeal to bear the cost of hiring a private court reporter or private court recording firm to make the verbatim record.
