Subject: Public Works State Appropriation Request

Background

The Public Works Department state appropriation requests would include the appropriations to construct the Public Works & Fire Department Training Facility and Roadway and Drainage Improvement Projects in 4 areas as per our CIP.

Public Works & Fire Department Training Facility

Scope to include- Construction of a Public Works facility that would include office space for the director and assistant, office space for the mechanic, break room for staff that would also operate as a conference room, training room, and bay area large enough to fit the garbage trucks and fire truck indoors out of the weather.

FY 26 \$250,000 - LOST Fund

FY27 \$3,000,000- LOST fund

Area 9 - Bay Point Causeway, Bay Point Drive, and sunset cove Drainage Improvement Project

Scope to include- elevate roadways where there will not be a negative effect on single story homes, replace and upsize stormdrains, replace curbs, and mill and resurface the roadway/or rebuild where needed.

FY26 \$250,000 - Start Design Services

FY27 \$2,500,000 - Complete design and potential start of construction

FY 28 \$4,500,000 - Construction

Area 7 – American Legion Dr. Roadway and Drainage Improvement Project

Scope to include – Update flume drainage system, replace curbs, replace sidewalk, and mill and resurface the roadway.

FY 27 \$1,500,000. Construction and minor design update

<u>Area 3A – 140th Ave. to 144th Ave., Virginia Ave., S Bayshore, and Marlyn Way., Roadway and Drainage Improvement Project.</u>

Scope to include- elevate roadways where there will not be a negative effect on single story homes, replace and upsize stormdrains, replace curbs, and mill and resurface the roadway/or rebuild where needed.

FY 27 \$100,000 – Start Design Services

FY 28 \$2,500,000 – Complete Design Services and potential start of construction

FY29 \$2.000,000 - Construction

<u>Area 4 – East Madeira Ave., N Bayshore to 145th, 1st Ave E., 145th Ave. to 148th Ave., Roadway and Drainage Improvement Project.</u>

Scope to include- elevate roadways where there will not be a negative effect on single story homes, replace and upsize stormdrains, replace curbs, and mill and resurface the roadway/or rebuild where needed.

FY 28 \$200,000 – Start Design Services

FY29 \$2,000,000. Complete Design Services and potential start of Construction

FY30 \$3,000,000 – Construction
