#### **ORDINANCE 2025-19**

AN ORDINANCE OF THE CITY OF MADEIRA BEACH FLORIDA, AMENDING CHAPTER 110 (ZONING) ARTICLE V. – DISTRICTS, DIVISION 7. - C-3, RETAIL COMMERCIAL, SECTION 110-321. - SETBACK REQUIREMENTS, OF THE CITY'S LAND DEVELOPMENT REGULATIONS TO REDUCE THE FRONT AND SIDE SETBACKS; PROVIDING FOR CONFLICT; PROVIDING FOR SEVERABILITY; PROVIDING FOR CODIFICATION; AND PROVIDING FOR AN EFFECTIVE DATE.

Ordinance 2025-19, C-3 Zoning District Setbacks implements the request from Text/Land Development Regulation Amendment Application TCH 2025-01 to reduce front yard setback and side yard setback in the C-3, Zoning District. City Staff supports this request since it would allow for pedestrian oriented mixed use development in the C-3, Zoning District.
