**MEETING OPEN TO THE PUBLIC:**

David Eldridge and Mitchell Socia introduced themselves to the board and expressed why, as business owners in the DDA, they want to become members of the MHDDA board.

**Finance Report**

Director Tucker stated that the only expenditure after our last meeting was a \$2,000 Sign Grant reimbursement to Beauty Room 11 for their sign grant project approved at the April 17<sup>th</sup>, 2025, BRA/DDA Meeting. The MHHP has also provided its first invoice to the DDA since our amended renewal of the service agreement with them. An invoice seeking a total of \$675 for services was submitted.

**DDA-26-06. Clock Tower Repair & Replacement.**

Motion to authorize The Verdin Company for the Clock Tower Repair in the amount of \$14,500 and authorize up to \$10,000 for additional services, including electrical work.

Motion made by Member Marsh, Seconded by Vice -Chair Van Buren.

Discussion followed on the budget for the clock tower repair, the possibility of changing the clock face, cost of maintenance, new technology options, the type and life expectancy of the new battery, long-term costs and the long-term future of the clock tower.
