Good morning:

We have received your Certificate of Occupancy application for 'Smokin Bear Tobacco' at 31076 John R Road, Suite C2. This property is zoned B-1, Neighborhood Business District.

Your proposed use is defined and classified as a "Tobacco/Smoke Shop" per Section 2.01 of the [Madison Heights Zoning Ordinance](#):

Tobacco/Smoke Shop: A store primarily selling tobacco products and smoking equipment.[...].

Tobacco/Smoke Shops are not a permitted use in the B-1 zoning district. Refer to Section 3.06 - Permitted Use Table, attached to this email and shown below:
