

**TOWN OF MEAD, COLORADO
RESOLUTION NO. 75-R-2024**

**A RESOLUTION OF THE BOARD OF TRUSTEES OF THE TOWN OF MEAD,
COLORADO, URGING THE REGISTERED ELECTORS OF THE TOWN OF
MEAD TO VOTE “YES” ON THE BALLOT ISSUE SEEKING APPROVAL OF A
\$739.8 MILLION BOND FOR THE ST. VRAIN VALLEY SCHOOL DISTRICT
(BALLOT ISSUE 5C) AT THE NOVEMBER 5, 2024 ELECTION**

WHEREAS, the Town of Mead (the “Town”), is a Colorado statutory town duly organized and existing under the laws of the State of Colorado; and

WHEREAS, the Town will be conducting a regular election on November 5, 2024, which regular election shall be conducted as a coordinated election with Weld County pursuant to the Uniform Election Code of 1992, as amended; and

WHEREAS, many of the school-age children residing within the Town attend St. Vrain Valley School District (“District”) schools; and

WHEREAS, the District Board of Education has placed a \$739.8 million bond on the November 5, 2024 state-wide election ballot that would allow the District to perform critical building maintenance, enhance and expand instructional space for career and technical education programming, provide additional classrooms and construct new school buildings, and continue to improve safety and security at schools, without increasing property taxes; and

WHEREAS, passage of the District’s proposed bond issue will also permit the District to focus on critical school building maintenance, including replacing outdated electrical, plumbing and HVAC components and construct new school buildings to address overcrowding and future projected enrollment; and

WHEREAS, this ballot issue will appear as “Ballot Issue 5C” on the November 5th coordinated election ballot; and

WHEREAS, the Board of Trustees finds that the passage of the District’s bond issue is necessary for the District to continue to provide excellent educational opportunities to children in the Town who attend these schools; and

WHEREAS, the Board of Trustees further finds that a strong, high-performing District is beneficial to the Mead community; and

WHEREAS, the Board of Trustees supports the passage of Ballot Issue 5C and urges all registered electors of the Town to vote “YES” on Ballot Issue 5C.

NOW THEREFORE, BE IT RESOLVED by the Board of Trustees of the Town of Mead, Weld County, Colorado, that:

Section 1. The Board of Trustees supports the passage of Ballot Issue 5C

Section 2. The Board of Trustees hereby urges the registered electors of the Town to vote “YES” on Ballot Issue 5C, proposing additional funding for the St. Vrain Valley School District.

Section 3. Effective Date. This resolution shall become effective immediately upon adoption.

Section 4. Certification. The Town Clerk shall certify to the passage of this resolution and make not less than one copy of the adopted resolution available for inspection by the public during regular business hours.
