#### I. 6:00 p.m. to 10:00 p.m. REGULAR MEETING

Mayor Colleen Whitlow called the Regular Meeting of the Board of Trustees to order at 6:00 p.m.

Community Development Director Jason Bradford presented the staff report regarding the proposed regulations.

Motion was made by Trustee Harris, seconded by Trustee Schranz, to further continue the public hearing regarding the Board's consideration of the proposed Code Amendments related to Renewable Energy Facilities to Monday September 30, 2024 at 6:00 p.m. at Town Hall. Motion carried 7-0, on a roll call vote.
