

**2026–2027 SCOPE OF SERVICES AND ANNUAL EXTENSION
AGREEMENT BETWEEN THE CITY OF MEDINA AND THE UNIVERSITY OF
WASHINGTON FOR LAW ENFORCEMENT SERVICES**

This 2026–2027 Scope of Services and Annual Extension (“Annual Scope”) is entered into by and between the City of Medina, a Washington municipal corporation, through the Medina Police Department (“City” or “MPD”), and the University of Washington, through the University of Washington Police Department (“UWPD”) (individually, a “Party” and collectively, the “Parties”), pursuant to Sections 1, 2, and 3 of the Parties’ Agreement for Law Enforcement Services dated August 6, 2024 (“Agreement”).

RECITALS:

WHEREAS, the Parties entered into the Agreement for purposes of allowing MPD to provide law enforcement services and officer presence for university events; and

WHEREAS, the Agreement provides that it may be extended for one-year periods beginning July 1 of each year, provided the Parties review and update the Scope of Services for the following year’s services; and

WHEREAS, the Parties desire to confirm the continued effectiveness of the Agreement, including for the period beginning July 1, 2025, and to document the updated Scope of Services for the 2026–2027 contract period; and

WHEREAS, the Parties have reviewed and updated the Scope of Services for the 2026–2027 contract period and desire to extend the Agreement through June 30, 2027;

NOW THEREFORE, in consideration of the terms and conditions set forth herein, the Parties agree that the recitals set forth above are incorporated herein as if set forth in their entirety and further agree as follows:

ANNUAL RENEWAL REQUIREMENT:

1. Scope of Services The Scope of Services is updated as follows:

Contract Period: The Parties confirm the continued effectiveness of the Agreement and agree that the contract period for this Annual Scope is July 1, 2026 through June 30, 2027, unless earlier terminated or further extended in accordance with the Agreement.

Dates and Staffing: MPD may provide overtime law enforcement officer services for UW home football games during the 2026 season, together with other special events as mutually agreed by the Parties. The number of officers, hours, and assignments for each event shall be coordinated by UWPD and MPD consistent with the Agreement.

Rates of Pay: Services provided under this Annual Scope shall be billed at the applicable rates established in the City of Medina Master Fee Schedule, Table E, as adopted or amended by the City.

2. **No Other Changes.** This Annual Scope updates the Scope of Services for the contract period stated above. It does not supersede or modify any other term of the Agreement unless expressly stated herein.
3. **Recitals; Capitalized Terms.** The recitals set forth above are a part of this Annual Scope. Unless otherwise defined herein, capitalized terms used in this Annual Scope have the meanings assigned to them in the Agreement or as set forth in the Ann.
