

The 2024 Medina Comprehensive Plan has been in-progress since 2023 with a majority of the work happening in 2024.

The initial draft plan was published on May 31, 2024, after which the City received comments from public agencies and the general public. Since then, the City has been preparing revisions to the previous draft of the comp plan in preparation for adoption before the end of 2024.

The revisions that have been prepared represent the minimum action needed to address the agency comments received while considering and incorporating public comments and City concerns that were received/identified since the draft was published.

### 10/28 Meeting Revisions

At the last meeting on 10/28 the City Council reviewed the draft of the Final Comprehensive Plan and a summary of all the changes that had been made to the plan in this update process.

Minor revisions and corrections were made in preparation for the City Council's public hearing prior to adoption of the plan. These revisions include
