# **AB 6244: Police Department Annual Report**

Police Chief Ed Holmes introduced the 2022 Police Department Annual Report.

Commander Mike Seifert presented information from the Operations Section covering calls for service, arrests, citations issued, and discussed resource options for those experiencing homelessness. He also spoke about the Department's use of force, and involvement in the Independent Force Investigation Team. Commander Seifert spoke about 2022 State legislation and how the Department responded to the legislation.

Commander Jeff Magnan spoke about the Services Section discussing records and evidence management including public records requests and storage and destruction of evidence according to retention schedules. He spoke about the community outreach programs that the Department facilitates, discussed Emergency Management, the completion of a CERT course in 2022, and projects that were completed in 2022.

Sergeant Scott Schroder spoke about employee departures and hires in 2022, discussed the focus on hiring and retaining outstanding officers, and presented on the ongoing training that the department receives.

Detective Sergeant Dominic Amici presented an overview of detective casework in 2022, spoke about the new School Resource Officer and his collaboration on an educational bike safety video, and discussed the special operations team.

Marine Patrol Sergeant Chad Schumacher presented an overview of the Marine Patrol work in 2022. He spoke about the area that the Marine Patrol covers, discussed the Marine Patrol responses and hours on the water, Seafair, and the emphasis on water safety education. Marine Patrol Sergeant Schumacher also spoke about the grant funding that the department receives.

Chief Holmes spoke about the community's response to the department in 2022 and thanked the community for their support of the Department.

The City Council asked questions and discussed the presentation.

# AB 6258: 2024-2029 Six-Year Transportation Improvement Program Review and Public Hearing.

Mayor Nice opened the Public Hearing at 6:06 pm. There being no public comments, Mayor Nice closed the Public Hearing at 6:06 pm.

Deputy Public Works Director Patrick Yamashita introduced the staff team working on the development of the 2024-2029 Six-Year Transportation Improvement Program (TIP).

Transportation Engineer Lia Klein presented background and purpose of the TIP, discussed the public engagement that has occurred since March through adoption on June 6, and spoke about program elements and priorities.

Finance Director Matt Mornick discussed TIP funding over the six years covered in the 2024-2029 TIP.

Street Engineer Ian Powell presented an overview of the Mercer Island street network, discussed pedestrian and bicycle projects, and spoke about projects related to the East Link.

Transportation Engineer Klein discussed the Island Crest Way Corridor safety improvements, reviewed new projects that were added to 2027 through 2029, and spoke about the next steps in the process.

The City Council asked questions of staff and provided feedback.

It was moved by Reynolds; seconded by Rosenbaum to:

Add the Mercer Way shoulder study for demarcation as a shared bike/ped facility.
