SUBJECT: 2022 Meeting & Planning Schedule

The purpose of this memo is to inform the Parks & Recreation Commission of the anticipated meeting and planning schedule for 2022.

Per the Commission's Bylaws, regular meetings of the Parks & Recreation Commission convene at 6:30 pm on the first Thursday of each month at Mercer Island City Hall in the Council Chambers. Due to previous access conflicts with Council Chambers, the Commission elected be hold their meetings at the Mercer Island Community and Event Center.

The 2020 and 2021 Commission meeting schedule was impacted by the Covid-19 global pandemic. In November 2020 the Commission began meeting virtually and conducted meetings over the Zoom platform with a start time of 5:30pm. This practice has continued throughout 2021.

Currently staff does not have a specific date for a return to in-person Commission meetings. It is anticipated that when in-person meetings are possible, the Commission will utilize technology only available in the Council Chambers and host their meetings at City Hall.

Staff is currently coordinating the Commission's 2022 meeting schedule with other boards and commissions to ensure collaboration as well as access to Council Chambers when permitted for in-person meetings. It is anticipated the Commission meeting schedule will continue (until further notice) on the 1<sup>st</sup> Thursday of each month at 5:30pm via the Zoom platform. Once in-person meetings are possible, staff will coordinate a transition plan with the Commission to confirm meeting location and any alterations for start times.

The schedule below depicts dates for the 2022 meeting schedule and some initial agenda items. Staff will be coordinating with Commission Leadership to schedule several agenda items not currently listed, including joint meetings with other boards and commissions, updates on capital projects, recommendations to City Council, and various policies for review and endorsement.
