EXECUTIVE SUMMARY

The purpose of this agenda bill is to authorize an amendment to the Interlocal Agreement with the South Correctional Entity (SCORE) jail (see Exhibit 1).

- Under State law, the City of Mercer Island is responsible for paying all jail costs associated with housing individuals for violations of misdemeanor level crimes occurring within the City.
- The City maintains contracts with the Issaquah City Jail, SCORE, and King County Jail. The Issaquah City Jail and SCORE are used for misdemeanor bookings, while the King County Jail is used primarily for felony bookings.
- The City utilizes the Issaquah City Jail as the primary jail service for cost efficiency and accessibility.
- Since 2011, the City has also maintained an Interlocal Agreement (ILA) with SCORE (see Exhibit 2), which provides back-up jail services when the Issaquah Jail is at capacity and serves individuals being booked on misdemeanor charges with medical or psychological conditions.
- From 2020-2022, the City’s annual cost for use of SCORE facilities has been approximately \$50,000 per year and usage patterns are not expected to change.

- Effective January 1, 2025, SCORE’s Administrative Board adopted a daily bed rate increase of 4% and amended the booking fee from \$65.00 to \$80.00. The hourly rate for transport/hospital security will be increased from \$85.00/hr. to \$89.00/hr. The rate adjustment requires an amendment to the ILA.
- The cost of the rate adjustment in 2025 will be absorbed in the Police Department’s budget.

BACKGROUND

Under State law, the City of Mercer Island is responsible for paying all jail costs associated with housing individuals for violations of misdemeanor level crimes occurring within the City. The state pays for housing individuals for felony level crimes. The City maintains contracts with the Issaquah City Jail, SCORE, and King County Jail. The Issaquah City Jail and SCORE are used for misdemeanor bookings, while the King County Jail is used primarily for felony bookings.

The City utilizes the Issaquah City Jail as the primary jail service for cost efficiency and accessibility. Since 2011, the City has also maintained an Interlocal Agreement (ILA) with SCORE (see Exhibit 2), which provides back-up jail services when the Issaquah jail is at capacity and serves individuals being booked on misdemeanor charges with medical or psychological conditions.

From 2022-2024, the City’s cost for use of SCORE facilities has been about \$50,000 per year and usage patterns are not expected to change.

ISSUE/DISCUSSION

Effective January 1, 2025, SCORE’s Administrative Board adopted a daily bed rate increase of 4% and amended the booking fee from \$65.00 to \$80.00. The hourly rate for transport/hospital security will be increased from \$85.00/hr. to \$89.00/hr. (see Exhibit 1).

The budgeted amount for SCORE services in 2025 is \$54,000. This budget anticipated an increase in SCORE rates and no additional resources will be needed. In addition to the fee changes described above, SCORE will no longer collect medical co-pays and the language in Section 2 of Exhibit 1 has also been revised.

RECOMMENDED ACTION

Authorize the City Manager to execute the amendment to the Interlocal Agreement with SCORE as substantially shown in Exhibit 1 to AB 6591.
