A RESOLUTION ADOPTING NEW BUILDING DIVISION FEES; AUTHORIZING BUILDING DIVISION OF THE COMMUNITY DEVELOPMENT DEPARTMENT TO COLLECT SUCH FEES; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the Idaho Legislature has amended Idaho Code section 54-1016(2)(h) to, inter alia, waive licensing and design review requirements for limited electrical contractors, limited electrical installers, and employees of companies holding a limited electrical contractor license where such persons are replacing or installing fire alarm communication devices;

WHEREAS, Idaho Code section 54-1016(2)(h) further requires such persons to obtain a permit for such replacements or installations, and limits the fee for inspections related to such permit to one hundred twenty-five dollars (\$125);

WHEREAS, this update to the City's fee schedule is necessary in order to comply with Idaho Code section 54-1016(2)(h) as amended and to clarify the processes and fees applicable to other fire alarm system installations and replacements;

WHEREAS, pursuant to Idaho Code section 63-1311A, following publication of notice on January 14, 2022 and January 21, 2022, and public hearing on January 25, 2022, the Meridian City Council did, by formal motion, approve new updated fees as described herein;

NOW THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF MERIDIAN CITY, IDAHO:

Section 1. That the following new and updated fees are hereby adopted and shall be included in the FY22 Citywide Fee Schedule:
