P. Gittings presented survey results (see attachment). The survey results were discussed by the subcommittee. Regarding a historic preservation district, the City does not currently have one. There was a district at the Mittleider Farmstead Historic District, which has since been torn down. If the TAG survey identifies an eligible historic district in downtown, there is interest the pan laying out steps to work towards a district. There may be other eligible neighborhoods. D. Pitts stated that it seemed there would be three "bucket" to put questions into: 1. Things that the Commission should do 2. Things that the consultant should do 3. Things that might be tabled. Things like identifying and working with other entities (ex- Meridian Arts Commission, Meridian Community Development Dept., Meridian Library District, Meridian Chamber of Commerce, etc) and ...engaging the commission in existing City events would be something the commission would do.
