**A RESOLUTION ADOPTING NEW AND INCREASING FEES; AUTHORIZING CITY DEPARTMENTS TO COLLECT SUCH FEES; AND PROVIDING AN EFFECTIVE DATE.**

**WHEREAS**, pursuant to Idaho Code section 63-1311A, following publication of notice on October 2, 2020 and October 9, 2020, and public hearing on October 13, 2020, the City Council of the City of Meridian did, by formal motion, approve new and increasing fees as set forth in *Exhibit A* hereto; and

**WHEREAS**, certain fees charged by City are decreasing or are no longer necessary, as set forth in *Exhibit A* hereto;

**NOW THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF MERIDIAN CITY, IDAHO:**

**Section 1.** That the new, and increasing fees set forth in *Exhibit A* are hereby adopted.

**Section 2.** That the Community Development Department and Public Works Department of the City of Meridian, respectively, are hereby authorized to implement and carry out the collection of fees set forth in *Exhibit A*.

**Section 3.** That this Resolution shall be in full force and effect on October 14, 2020.
