Below are summaries of relevant correspondences received by City Staff since the last TC meeting.

CORRESPONDENCE #1:

Good afternoon Dayna,

Thank you for your email, it has been received by the Mayor's Office, we appreciate you contacting us and sharing your concerns about traffic and speeding vehicles in your neighborhood.

Our Transportation Commission and supporting staff review these types of concerns and issues. I have copied Hether Hill, the Long Range Associate Coordination Planner, and ask that she reach out to you to discuss the issues and get some additional details so she can help determine the best path forward.

Additionally, I have copied our Police Chief, Tracy Basterrechea on this email so he is aware of your experiences and I will ask that he look into traffic enforcement in that area, and what options there may be from an enforcement standpoint, and coordinate with Hether as well.

As the Ada County Highway District (ACHD) regulates the local roads in Meridian and are the lead agency that manages traffic calming measures, I want to be sure you also have their information. There is a link (found HERE) on ACHDs webpage at the bottom of the Traffic Calming page that allows you to complete a Traffic Investigation Report form their team. I encourage you and Hether to talk first before entering a ticket as Hether can help identify the best first steps as our Transportation Commission and staff regularly engages with ACHD as well.

Again, thank you for reaching out, as we appreciate you sharing your thoughts and bringing this to our attention.

Subject: Unsafe Traffic on Ustick

Message: Hello,

I am writing to start a converstation about the stretch of road between Meridian and Linder on Ustick. I live just off this road down Venable and travel multiple times a day on this stretch. I personally have seen 2 car accidents right in front of me from people turning left onto Ustick, multiple close calls, and car speeds of up to 55 mph if I were to guess. My thought is that once people pass Settler's Park heading west they pick up speed and create a very unsafe intersection for people turning left onto Ustick. Not only that, but the increase in housing has created even more traffic on these side streets, and drivers (in my opinion) are feeling pressure to take risks in response to the frequent backups. There are only 2 speed limit signs on this stretch and not very noticeable in my opinion. I have a new driver and 2 soon-to-be drivers and it's scary as a parent to have them on the road with so many distracted and speeding drivers, especially on this road. I hardly ever see it being patrolled either. Perhaps putting up more signage, a speed radar sign, or even a light at Venable to create a safer intersection would be helpful. Good afternoon,

Thank you for reaching out. As Councilwoman Strader mentioned, I am the staff liaison to the Meridian Transportation Commission and to partner agencies on transportation related issues. I will present your concerns to the Commission, which also includes representation from our partner agencies (ITD, ACHD, West Ada School District and Police) during November's Transportation Commission Meeting. I will also include your correspondence as part of the agenda packet for their review. This is common practice for correspondence received regarding traffic and/or safety concerns on our local road network.

You are correct in that a roundabout is being designed for McMillan and Black Cat. Construction is currently programmed for 2029 and may be subject to change. Thanks both. Is there a good way to communicate these issues to achd?

I will look at the plans you sent. I know a traffic circle is coming to Black Cat and Mcmillian and hopefully that will include some accommodation for cyclists and pedestrians. Currently it's impassable even for pedestrians.

My my frequent issues for cycling access involves either Ten Mile or Linder. Ten Mile has a bike lane but the area between mcmilliam and Ustick frequently has construction debris.

Linder has an inconsistent bike lane and considerable debris running north into Eagle from Chinden. The closure of Eagle Island has made it impossible to avoid.

The pedestrian and bike facilities on Black Cat have been a huge source of frustration for us, so I share in your comments!

The ACHD controls our roads and bike lanes, but thank you for reaching out because these are all important comments for us! While the City of Meridian doesn't control the bike lanes directly, we do have a liason who works closely with ACHD. We also have a Meridian Task Force that is focused on these crossings and so forth and elevating the highest priority items.

I am cc'ing Heather our liason for transportation issues to see if she can follow up on this feedback. Heather - let us know please if we can make sure to get some remediation of Chinden going as well as feedback on this crossing issue as soon as possible.

My other suggestion which I'm not sure if it will help or not, is to make sure you have a copy of the master pathways plan for the City of Meridian. The connectivity isn't perfect, but we are adding to it all the time and there are some great routes where you can avoid the roads almost entirely on the multi-use pathways along the canals. The master pathways plan is located here, but if you have a specific way you are trying to go we can probably find someone to advise...

Hi Liz - I could use help figuring out whom to address some bike lane issues with. I have a few issues:

- 1) The debris left in the bike lanes (and sidewalks) on Chinden from the sealing is a hazard to both cyclists and motorists. There are piles of small rocks now in the bike lanes and the work was done weeks ago.
- 2) There are now bike paths in the neighborhoods along Black Cat between McMillian and Ustick. However, the crossing point on black cat is a hazard. That is a 40 mph road and there isn't even a sign calling out the bike crossing. One of the paths has poles to block cars, but they are down, the other side has no protection.
- 3) I also wanted to revisit the general haphazard nature of bike lanes in Meridian, which is still a persistent problem. The bike paths I mentioned above are great, but one thing that is frustrating is that unless you live in those areas, you can't get there safely on a bike. Black Cat has no bike lane and not even a sidewalk. Between Mcmillan and Chinden there is some bike lane on part of Black Cat, but not the whole road and seemingly without reason.

As you may be aware a cyclist was recently killed on Black Cat in South Meridian last month in an area with no bike lane.

Thank you very much for reaching out and identifying an area of concern you have with crossing Chateau Drive to access Chateau Park. First, I am happy to know that you and your sister frequented the park and enjoyed its use! Second, I appreciate you reaching out an letting me know of your concern and perspective about crossing the road and how you felt unsafe. While I am sad to see your family leave Meridian, I am invested in safe pathways and walkability for families and students.

As a City, I have asked that our staff develop an intersection and pedestrian safety task force (MIPS). That group was formed back in 2023 and identifies roadways, intersections and crossing that could be made safer, and then works to implement changes to those areas. While I have not seen this specific location that you made me aware of on those lists, I will ask that Hether Hill, our Long-Range Associate Planner work with you to get a better understanding of the concern, and whether it should be part of that MIPS effort.

To that, please feel free to call (or have your parents call) Hether at 208-489-0319 to further discuss and identify the area and possible solutions. Again, thank you for bringing this to our attention and while we will miss you as Meridian residents, I appreciate you keeping safety of all Meridian residents in mind with your communication.
