A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MERIDIAN TO AMEND THE FUTURE LAND USE MAP OF THE CITY OF MERIDIAN COMPREHENSIVE PLAN TO APPLY THE “CIVIC” LAND USE DESIGNATION TO IDENTIFIED EXISTING AND ANTICIPATED WEST ADA SCHOOL DISTRICT SCHOOL SITES AND CITY-OWNED PROPERTIES; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City Council has the authority pursuant to Idaho Code § 50-302 to establish resolutions not inconsistent with the laws of the state of Idaho as may be expedient, in addition to the special powers therein granted, to maintain the peace, good government and welfare of the corporation and its trade, commerce and industry; and

WHEREAS, the City of Meridian Comprehensive Plan was adopted in December 2019 as resolution 19-2179; and

WHEREAS, the City Council has deemed it appropriate to amend the Future Land Use Map of the City of Meridian Comprehensive Plan to apply the “Civic” land use designation to identified existing and anticipated West Ada School District school sites and City-owned properties, with some minor adjustment to adjacent properties, as depicted on Exhibits 1 through 7, which are attached hereto and incorporated herein by reference; and

WHEREAS, all notices, hearings, and required information necessary to make a final decision as required by the Idaho Local Land Use Planning Act to amend the adopted City of Meridian Comprehensive Plan have been met.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MERIDIAN, IDAHO AS FOLLOWS:

SECTION 1. Pursuant to Idaho Code § 67-6509, the City Council hereby amends the City of Meridian Comprehensive Plan and Future Land Use Map as depicted on Exhibits 1 through 7 under “Proposed Future Land Uses.” A copy of this Resolution and the attached amendment shall be held on file in the office of the City Clerk.

SECTION 2. EFFECTIVE DATE. This Resolution shall be in full force and effect immediately upon its adoption and approval.
