Hello Karen,

Thank you for reaching out, and for sharing the Woodbridge HOA's ongoing concerns.

The transportation study you referenced was broader than the Woodbridge neighborhood and was prepared at a high, land-use-planning level. It did not include design concepts or recommendations for specific transportation improvements. City Council received and discussed the study last night, and at this time has not identified specific next steps. The general takeaway was preserving long-term transportation connectivity rather than identifying near-term projects. More immediate or location-specific actions would typically fall under ACHD's purview.

If you have not already done so, I would recommend watching the recorded Council discussion at the link below, as it provides helpful context on the study's purpose and limitations.

Given the history of traffic-related requests in Woodbridge—often with differing perspectives among neighbors—the most appropriate venue for discussion with the City would be the Transportation Commission (TC). That would also align with how Council would typically direct these types of requests before elected officials become more directly involved. If there are specific questions about the study itself, staff can help clarify those, but requests for further discussion or action would be best brought forward through the TC as a future agenda item.

For awareness, I will include this correspondence in the Transportation Commission's agenda packet for their meeting next Monday, February 2, at 3:30 PM, as part of staff communications. The Commission may discuss it informally at that time, though no action would be anticipated. The TC will also receive a more formal update on the study in March.
