CREATES

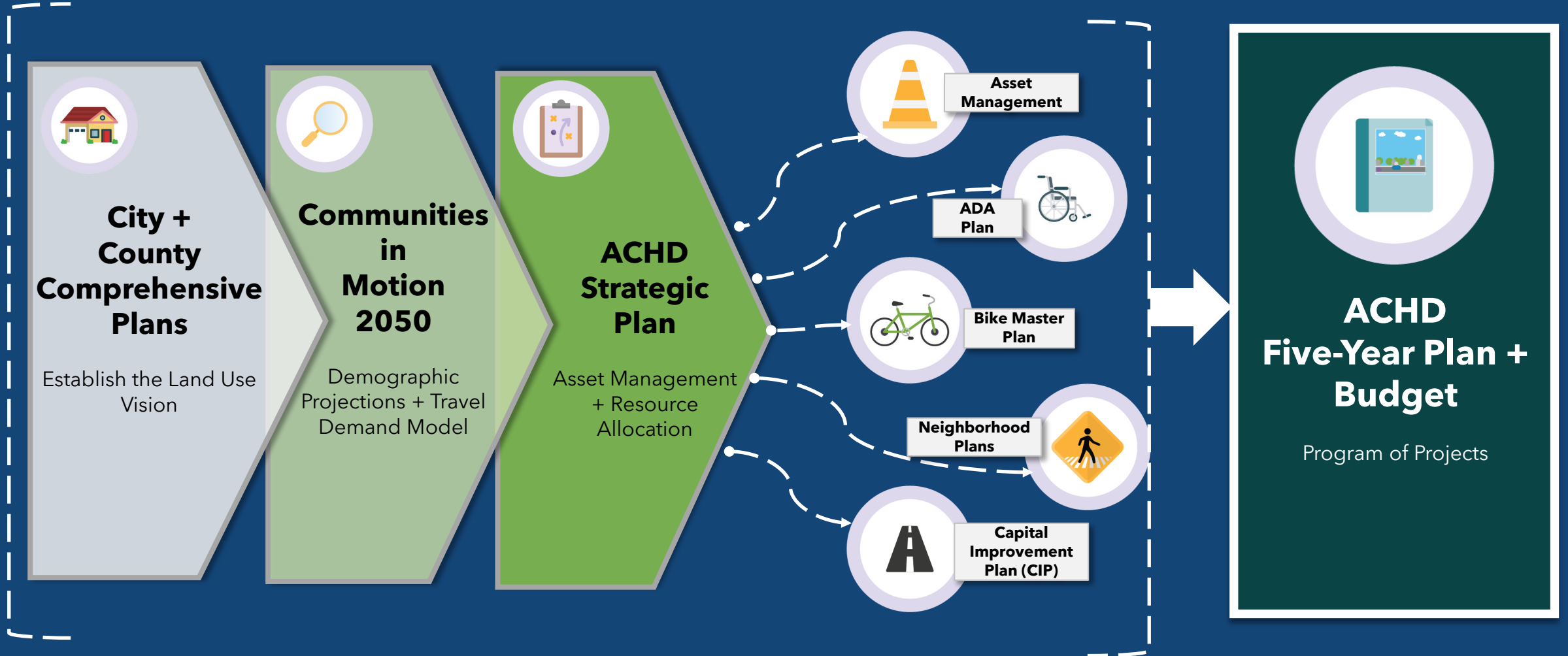
Creates transparency of planned activities



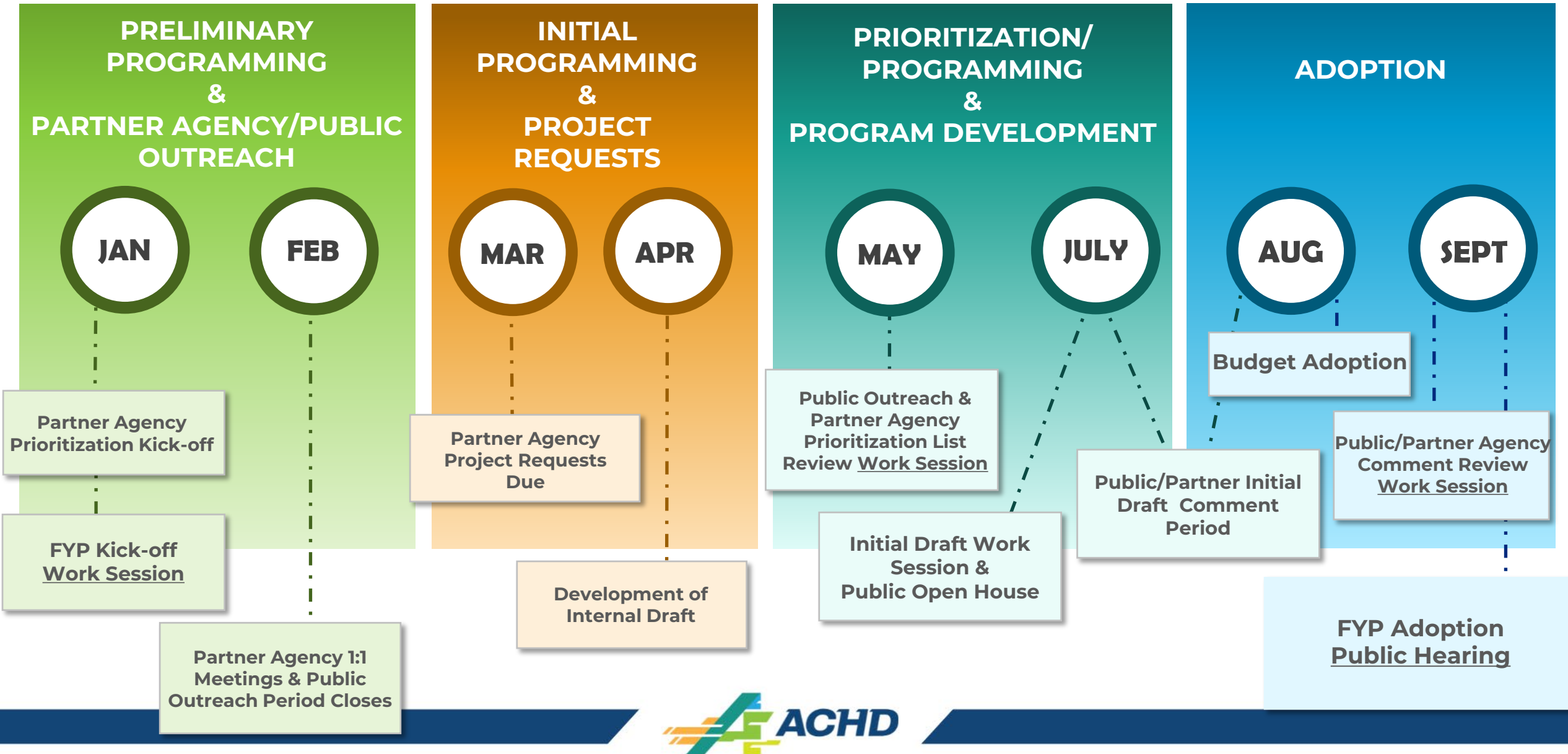
COORDINATES

ACHD's Vision: Programming Framework

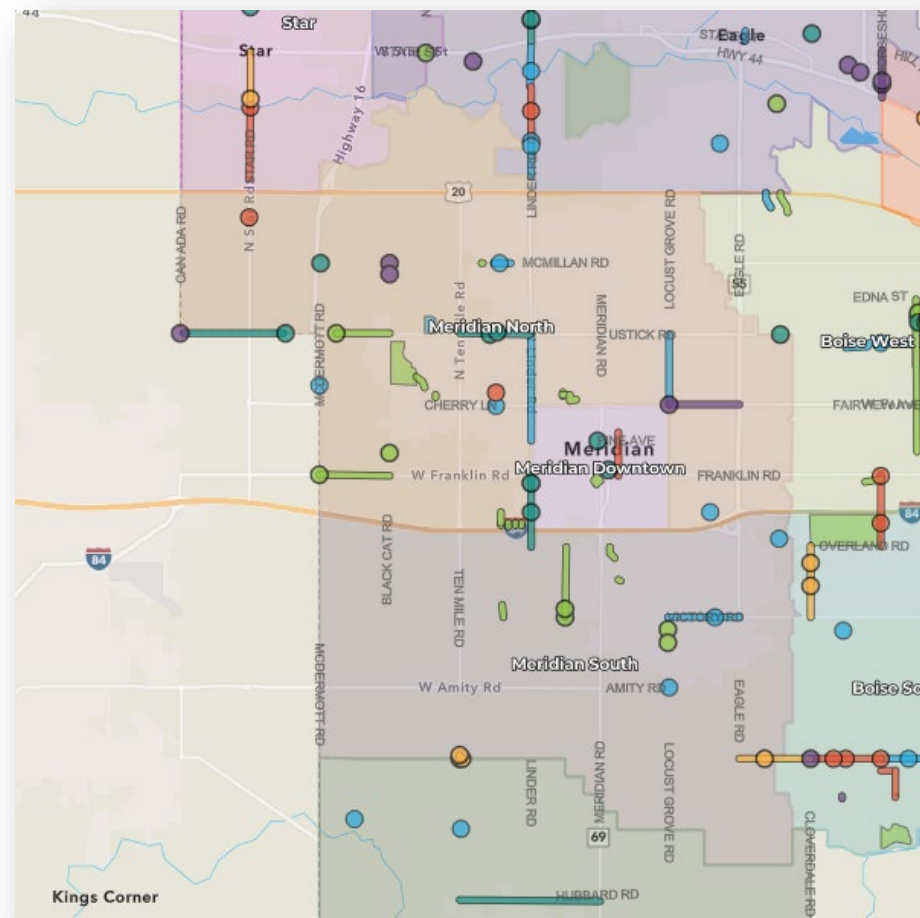


Typical FYP Schedule

- Investment over \$110.0 Million
- 2026 Construction Projects
 - Ustick Rd, Black Cat Rd to Ten Mile Rd
 - Ustick Rd, Phyllis Canal to Owyhee Storm
 - Ustick Rd Ten Mile Rd to Linder Rd
 - Stoddard Rd, Victory Rd to Overland Rd
 - Linder Rd Overpass, Overland Rd to Franklin Rd
 - Black Cat Rd Railroad Crossing (CN2027)



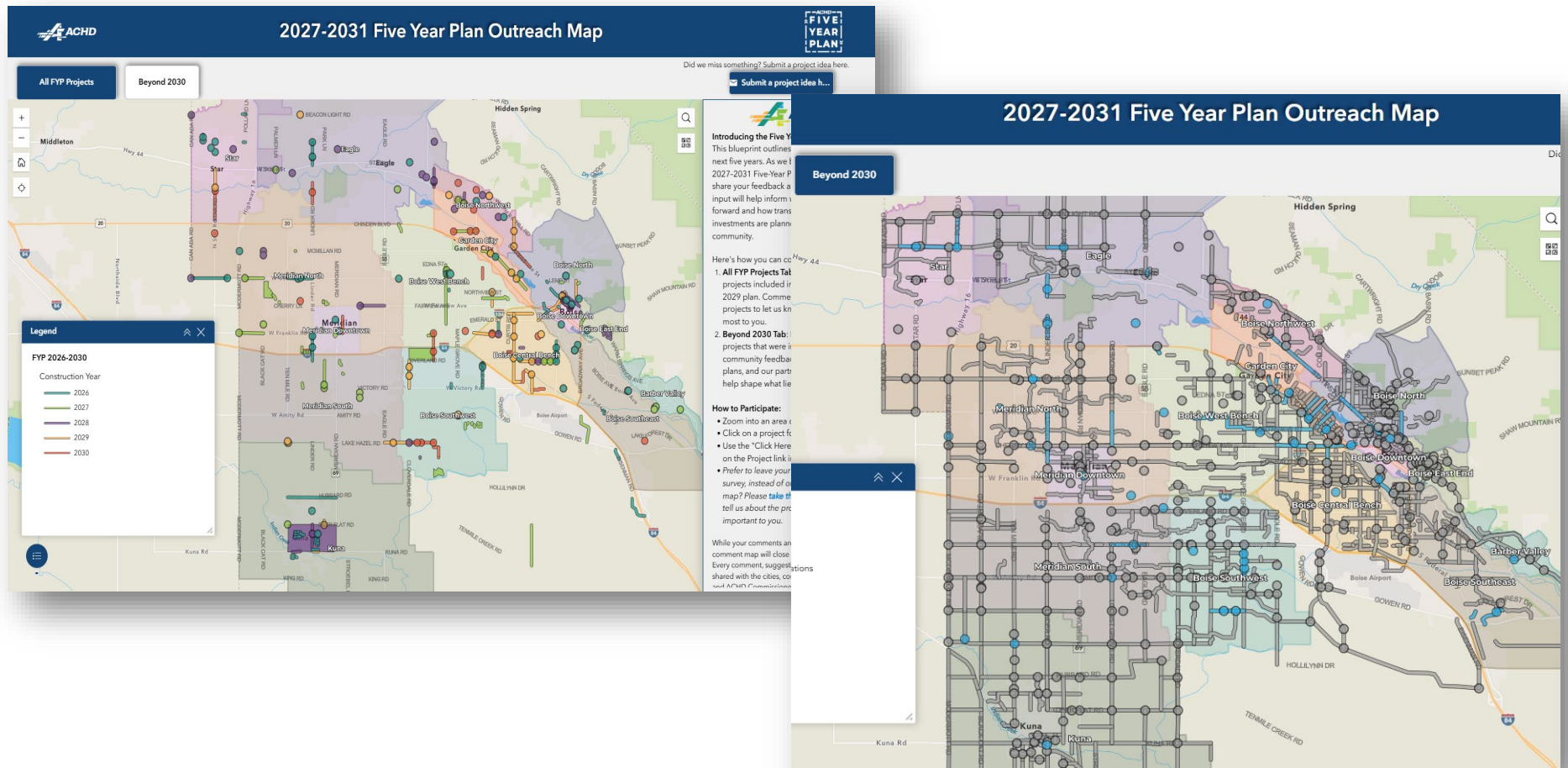
