2. Historic Walking Tours: July 19 Tour led by Johnston, Pitts; August 16 needs Commissioners

B. Johnston and C. Schiffler attended the meeting and one of the ideas presented was to give funds to SHPO who is already in the process of doing a study on historic laterals. An MOU has been executed and the Developer will give SHPO \$2,000 towards that long term study.

6. Updates: Historic Preservation Plan Progress

C. Schiffler has work to do on the Goals, Objectives, and Strategies of the Plan to proceed with the Preservation Plan. Otherwise, there are no updates.

7. **Updates:** Elongated Coin Machine

K. Freeze stated V. Ivanov (Library Assistant Director) is interested in installing the coin machine at the Cherry Lane Library, but they don't want to pursue the project until after they finish renovations in 2026. B. Johnston said he spoke to C. Schiffler, and the Mayor's Office is in favor of the coin machine, but they would like the commission to research finding a sponsor to fund it. B. Johnston volunteered to reach out to potential donor. C. Schiffler stated the Mayor suggested reaching out to Josh Everts, owner of the Heritage Building and the Vault as a potential sponsor since they might be on one of the coins and it might be a good location for the coin machine.
