Below are summaries of relevant correspondences received by City Staff since the last TC meeting.

Records Ave at Kleiner Park

In response by the Mayor to lower speeds to 25 MPH on Records and reevaluate using loose rocks in landscaping on Eagle, ACHD sent this response:

I spoke with Plans and Projects this morning and they will be looking to see if there is something that can be done with this [the rocks] and will also work to focus on hardscape going forward as you suggested. Our Traffic team will be addressing your requests regarding 25 MPH on Records for River Run to Fairview and looking into speed humps etc. at Kleiner.

Signal Timing at I-84 and Meridian Road

Due to traffic backing up ITD inquired if the City had asked ACHD to change signal timing at I-84 and Meridian Road. The City did not request any changes, but staff followed up with ACHD to determine if changes were made. This is the response that was received:

Over the past couple of weeks, we had noticed a backup, especially for the WB Off Ramp during the PM Peak. Wil has been making some adjustments to try to improve the conditions and I think it has improved over the last few days for sure. He will be looking at it more this week and tweaking the new timing plans as needed.

I think that the Meridian IC is seeing some increased traffic volume due to the closure of Ten Mile from Overland to Amity. We will keep an eye on it.

Citizen Complaint Regarding "No Parking" Signs in Woodbridge

We recently received the following complaint:

Hello.

I live in the Woodbridge neighborhood in Meridian. Recently the city has put "no parking" signs all around our neighborhood effectively eliminating any reasonable place for our visitors to park (no exaggeration). I hear this is happening all across the city. I am writing to let you know that this will make the city less desirable and will negatively impact growth and property values in Meridian. Please consider having these taken down. The justification we have heard is that it is difficult for EMS to get through the neighborhood, which is rubbish. I have seen EMS and bigger vehicles come through for years with no problem. If anyone with

the City of Meridian has driven through the North End of Boise, our streets are enormous comparatively. These signs are ugly, and while I understand easements, it feels like an encroachment on private property, which is just un-Idahoan. It is also classist, making it so that only people with huge garages and driveways can have get togethers. I have heard all my neighbors express the same sentiments. If neighbors can't have a couple people over because there is no parking in this city, people will leave. Please inject some reason into where these signs are going and rein the City of Meridian back in. This is a great city, and over-regulation, and government over reach is going to ruin it. June Action Items:

- <u>Executive Director Annual Review</u>. Approved an increase in compensation for the COMPASS Executive Director, following a discussion in Executive Session.
- <u>CIM 2050 Projects</u>. Approved Communities in Motion 2050 (CIM 2050) project priority rankings and unfunded project lists.
- <u>CIM 2050 Implementation</u>. Approved CIM 2050 <u>implementation policies</u>. The implementation policies and priority projects (above) constitute the final two Board actions that inform the draft CIM 2050 plan. The draft plan is scheduled for release for public comment this fall.
- <u>End-of-Year Priorities</u>. Approved priorities for the End-of-Year and Redistribution Program, should funding become available.
- <u>High-Capacity Transit Study</u>. Directed COMPASS staff to fund a high-capacity transit Planning and Environmental Linkages study in the draft FY2023-2029 Regional Transportation Improvement Program (TIP).
- <u>TIP Modification</u>. Approved a Board Administrative Modification to the <u>FY2022-2028 TIP</u> to decrease the cost of one project and increase the cost of two projects.

June Information/Discussion Item:

<u>FY2023-2029 TIP</u>. Received the draft FY2023-2029 TIP for review, prior to public comment later this summer.

Both items will be brought to the full COMPASS Board of Directors for ratification at the June 27, 2022, Board meeting as part of the Consent Agenda.
