ORDINANCE 2024-3434

TOWNSHIP OF MIDDLETOWN

An Ordinance Providing Funding For Acquisition Of Property For The Township Of Middletown And Appropriating \$2,100,000 For Such Purpose.

BE IT ORDAINED BY THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF MIDDLETOWN, IN THE COUNTY OF MONMOUTH AND STATE OF NEW JERSEY, AS FOLLOWS:

- <u>Section 1</u>. The Township of Middletown, in the County of Monmouth, New Jersey, authorizes acquisition of property located at 127 Hubbard Avenue, Block 1030, Lots 7 and 10, on the Official Tax Map of the Township of Middletown, to be funded from the sources specified in Section 2 of the Ordinance.
- <u>Section 2</u>. The amount of \$2,100,000 is hereby appropriated for the purposes stated in Section 1 of the Ordinance and which amount was funded from the Open Space, Recreation, Farmland and Historic Preservation Trust Fund in the amount of \$2,100,000.
- <u>Section 3</u>. In connection with the purpose and the amount authorized in Sections 1 and 2 hereof, the Township determines the purpose described in Section 1 hereof is not a Current Expense and is an improvement which the Township of Middletown may lawfully make as a general improvement.
- <u>Section 4</u>. All ordinances or parts of ordinances which are inconsistent with the terms of this Ordinance be and the same are hereby repealed to the extent of their inconsistency.
- <u>Section 5</u>. This Ordinance shall take effect immediately upon due passage and publication according to law.
