OPEN DISCUSSION

Abigale: Bucking Brew:

She wanted to know if they could close the road North of the Oregon Trail and West High Way Street. They are doing a fundraiser for the 8 year old boy that was hurt and they are trying to help raise money for the expenses. Mayor asked if they have talked to anybody about traffic control. Mayor told her to contact the Mills Police and the Public Works director. It's a good idea the Mayor said but we need to make sure all are safe.

Laura Ryan: Beacon Club:

Laura is wanting to get the City's approval to have a concert in the parking lot. They have done this a couple of years ago and the event would be June 26th, 2021. Laura is meeting with the people in the next day or so and want to make sure we are ok with it. The Mayor stated to Laura has filled out the required paperwork that the City request. The City Clerk stated for her to stop by the office to pick the packet up. The Mayor at this time did not see any problems with the concert.

John Gudger: 827 Fossil Butte

John was stating to Council the problems with the planning and zoning codes we have. He wanted to propose some changes that he feels are not bad but would help with the lightening problem. John has contacted Jason Lewis with Lisa Burrige and he has help a lot but feels that the Mills codes needs to have some sort of lightening requirements that is not intrusive to the residents. John stated that he has two issues. The first one is light pollution. John hared in the work session how we can help with this. The seconded is landscape buffering. John feels that with the buildings that have gone behind him will impact the resell of their houses. John feels bad that he did not look over the plans more carefully when he first notice the buildings going up. He said he looked over them but failed to look at the outerwall plans. The Mayor stated that he will look more into it and thanked him for his ideas on the lightening problem.

Shawn G: Update on Buffalo Meadows.

Shawn was giving an update on the Buffalo Meadows Project. He plans to give an update each month. He stated that it is moving along good. The grading is almost complete. We are going to move the sewer lkne to the west to tie into the east and south. They have finally got the DEQ permits that have been needed. We have a permit from Regional Water to move the line that is running under people's houses. He told the council that we are still on track to being done this fall. Mayor wanted to know when Badger will re-open. Shawn stated it should be opened by Monday. They will move dirt for the sanitary sewer. He says he will not close Pontiac but will direct the traffic. Mayor wanted to know if we can mill and overlay on Pontiac. Shawn stated that he did not see a problem with this. It is an expense that is covered under eligable expenses. Mayor stated that we will probably need new fire hydrants as well.

Kathy Brumer:

Kathy wanted to address the council on the lighting issue as well. She stated that she has black out curtains and can still see the light coming in. Something needs to be done with this. The lights are so bright. Mayor stated that we will look into this. Kathy also wanted to talk about the trash on Chamberlain. It is all over and has been there for the last couple of years. She also wanted to about the contractors and how they park. She almost got hit because they park the wrong way. Mayor stated that he will said the building inspector out. He final question was how do we get a new post office in Mills. The parking is horrible and the post office is full. New people have to go to Casper to get their mail. Mayor stated that we are working on this as well. It is very complicated and we need to write our legislators to let them know what is happening. She stated that other areas have the boxes and she would like them on Fossil Butte and well. She is to give her name to the Community Development Director and they will work together.
