**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MILPITAS AUTHORIZING
THE CITY TO CONTINUE PARTICIPATION IN THE CITIES ASSOCIATION OF SANTA
CLARA COUNTY PLANNING COLLABORATIVE AND TO PROVIDE FUNDING TO
CONTINUE CONSULTANT SERVICES TO SUPPORT THE PLANNING COLLABORATIVE**

WHEREAS, the City of Milpitas is a member of the Cities Association of Santa Clara County; and

WHEREAS, the members of the Cities Association of Santa Clara County will benefit from technical consultant services to assist in the evaluation of the Regional Housing Needs Allocation (RHNA) methodology, proposed or pending housing legislation, and other related housing matters; and

WHEREAS, the members of the Cities Association of Santa Clara County recognize that each jurisdiction has a responsibility to plan for its fair share of housing; and

WHEREAS, the members have agreed to work collaboratively to produce more housing in the region; and

WHEREAS, technical assistance will help staff prepare high quality housing planning documents, implement process improvements to accelerate housing production, and facilitate compliance with the sixth cycle of the housing element; and

WHEREAS, the members have agreed that having a unified voice regarding the upcoming RHNA process, proposed or pending housing legislation, and other housing implementation could result in greater effectiveness on housing issues.

NOW, THEREFORE, the City Council of the City of Milpitas hereby finds, determines, declares, and resolves as follows:

1. The City Council has considered the full record before it, which includes, but is not limited to, the supporting documentation, testimony by staff and the public, and other materials and evidence submitted or provided to it. Furthermore, the recitals set forth above are found to be true and correct and are incorporated herein by reference.
2. The City Council supports a regional housing collaborative and authorizes the City to continue participation in the Cities Association of Santa Clara County Planning Collaborative.
3. The City Council approves the appropriation of funds as set forth below to contribute toward continued consultant services to support the Planning Collaborative.
4. The City Council agrees to provide to the Cities Association of Santa Clara County a funding amount of \$10,000 if all sixteen jurisdictions (fifteen member jurisdictions and the County) continue in the Planning Collaborative, for the purpose of funding continued consultant services to Planning Collaborative members regarding the RHNA process, RHNA methodology, recently enacted State housing laws, proposed or pending housing legislation, and other affordable housing matters.
