The Planning Director read a letter from the City Attorney recommending reconsideration of Use Permit No. 78 and "S" Zone Approval for a Coin Operated Car Wash to be located at 542 South Main Street on the grounds that there was not sufficient evidenc in support of the finding and that the finding can not support the decision of denial issued by the Commission at its meeting of November 12, 1964.

The Planning Director stated that the Staff recommended approval subject to the following Special Conditions:

- 1. That the entire area be paved with Asphaltic-Concrete.

- 3. That all landscaping be to the approval of the Planning Commission.
- 4. That prior to the issuance of any Building Permit, the Applicant shall post with the City a Cash Deposit of an amount to be determined by the Planning Commission assuring the completion of all landscaping approved by the Commission The Cash Deposit shall be fully refundable upon completion of required landscaping to the approval of the Building Official and upon receipt by the City of written request for said refund signed by the Applicant.
- That all codes and ordinances of the City of Milpitas and the Milpitas Sanitary District be complied with.

- 8. That prior to any field engineering required of the City of Milpitas for the street improvements, the Applicant furnish a Record of Survey of the land parcel involved.
