ANNOUNCEMENTS & FUTURE AGENDA ITEMS

City Manager McHarris announced the following:

- The Midtown plan is on track to start in July. Community meetings will be held to get ideas and input. The meetings will be starting this month and going through June. For more Information on this please go to the Planning Department's webpage on the City's website.
- 2. The City is starting an in-home COVID19 vaccination program. City staff has been working closely with the Santa Clara County of Public Health to roll out this plan. The County will be setting up the appointments and determine the eligibility for the program. The County has collaborated with the City to determine vaccination locations. The Fire Department will begin the vaccinations on April 14, with an estimated five vaccines given every day.
- 3. The new Finance Director, Lauren Lai, was formally introduced.

Councilmember Phan announced the Kiwanis Club is having a fundraiser at Giorgio's Monday, April 12, and Tuesday, April 13, from 11:30 a.m. to 8:00 p.m. He asked that everyone bring a voucher which can be found on the Kiwanis Club Facebook page and join in supporting this community organization.

Councilmember Chua announced that the Santa Clara Milpitas Library will be opening on April 11 and made the following requests:

- 1. Create a plan on how to increase the number of businesses doing business with the City of Milpitas and would like this request to be included in the task list.
- 2. Receive statistics on how many Milpitas unhoused were assessed and what homeless sites the City has cleaned up. She requested that this information be provided by the end of April or beginning of May.

Councilmember Dominguez spoke about the following:

- Senate Bill 823 closing the California Department of Juvenile Justice which is the State system that currently houses and treats youth who have committed the most serious crimes. She stated that now the youth will be housed locally, and the County will be hosting some facilitation community forums on April 7, from 5:00 – 7:00 p.m. and another one on Monday, April 12, from 5:00 – 7:00 p.m. The forums will be available in Spanish and English.
- 2. Requested a conversation about developing a pilot neighborhood association, with direction to staff to get more information and look into the best practices for other

cities to determine the appropriate role for the City in terms of private neighborhood associations.

18. Discussion on Providing a Second Round of Small Business Grants Using CDBG/Federal Funds to Help the Small Business Community Vice Mayor Montano presented her proposed plan, stating that she would like to help the small businesses as the City did in the first round, but would like an emphasis on daycare centers. She suggested that round two of the grants total \$250,000 with approximately \$40,000 to be used to help daycare centers. She stated that since the City partnered with Enterprise Foundation on round one of the business grants, she would like to use their services again to act as the fiscal agent and administer the grant program with the same service fee of 5%. She discussed keeping the terms of eligibility the same as the first round with the exception of changing the language for daycare, commercial spaces, and home-based businesses.

Dennis King spoke about the services they provide and helping small businesses.

Council discussed funding sources, the possibility of funding this program through the American Rescue Plan, and requested a cost analysis for services be provided when this item comes back to the Council.
