REF: Enhanced Crosswalk Striping & Beacons/Radar Speed Feedback Signage, CP 3454 &3458, City of Milpitas – BID PROTEST

Sirs:

Pacific Electric Contracting Inc is protesting any potential award to the Apparent Low Bidder - Bear Electrical Solutions- (B.E.S.) for the above-named project for the following reasons:

- 1. B.E.S.'s bid is a not a balanced bid per 00 21 13- Instructions to Bidders Item #30 (page 11) and should be considered non-responsive. Refer to items #9,#10 & 11 both regarding the Radar Speed Feedback Signs. Items #9 & #10 are Furnish and Install items with costs of \$10,200.00 and \$9200.00 respectively. Both are lower than the quoted cost of the sign itself \$11,680.00 Each (Material Only) before taxes (see attached quote). Similarly, Item #11 Radar Speed Feedback Sign Trailer, which is purely a supply only item with no construction involved, is listed at \$8,600.00 each whereas the quoted vendor price is \$20,860.00 each. The three unit prices in question are both well below the Engineer's Estimate. It's possible that the apparent low bidder has artificially moved costs from Item #9, #10, and #11 to the three Add Alternate items knowing that the basis of award is based on the base bid amount solely.
- 2. B.E.S's low price for items #9,#10 & #11 could also indicate a pending Request for Substitution in advance strictly for the sake of being awarded the bid. The City of Milpitas was explicit in the selection of the approved products for the Radar Speed Feedback Signs (Fortel Traffic VCalm or approved equal. Per California Contract Code, there is procedure in place to evaluate "approved equal" products. But this happens after the City has awarded the bid and enters a contract. The City under pressure from the Contractor and at risk of delaying the project is forced to accept a potentially inferior product.

It should be noted that the Second Bidder, Pacific Electric Contracting Inc has submitted a balanced bid, is quoting the City's specified equipment and in addition, when adding the Base Bid and Add-Alternates 1A, 2A, and 3A represents a total lower overall bid though the criteria for low bidder is only based on the base bid.
