## A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MILPITAS APPROVING THE PROJECT PLANS AND SPECIFICATIONS, AWARDING A CONSTRUCTION CONTRACT AND AUTHORIZING THE INTERIM CITY MANAGER TO EXECUTE THE CONTRACT WITH THE LOWEST RESPONSIBLE BIDDER SUBMITTING A RESPONSIVE BID, CHRISP COMPANY, IN THE AMOUNT OF \$116,130.00 FOR THE TASP ON-STREET PARKING <br> PROGRAM, PROJECT NO. 2017, AND AUTHORIZING THE ENGINEERING DIRECTOR/CITY ENGINEER TO NEGOTIATE AND EXECUTE CONTRACT CHANGE ORDER(S) IN AN AGGREGATE AMOUNT NOT TO EXCEED \$17,420.00 FOR THE PROJECT

WHEREAS, TASP On-Street Parking Program, Project No. 2017 (referred to herein as "Project") provides for the construction of sign post and installation of 4-hour time limited parking signage on public streets within a half-mile around Milpitas Transit Center per Ordinance No. 43.212 on the following street segments:

WHEREAS, the Engineer's Estimate for the Project is $\$ 125,000$; and
WHEREAS, the Project was advertised and one (1) sealed bid proposal was received on September 6, 2019. The lowest responsible bidder submitting a responsive bid is Chrisp Company, in the amount of \$116,130.00; and

WHEREAS, no bid protest was filed with the City within five (5) days of the bid opening as set forth in the Project specifications; and

WHEREAS, sufficient funds to award the Project are available in the Project budget; and
WHEREAS, staff recommends the City Council approve the Project plans and specifications; and

WHEREAS, staff recommends the City Council award a construction contract to Chrisp Company, the lowest responsible bidder submitting a responsive bid for the Project, and authorize the Interim City Manager to execute a contract in the amount of $\$ 116,130.00$ in accordance with State law; and

WHEREAS, staff recommends the City Council authorize the Director of Engineering/City Engineer to negotiate and execute change order(s) in an amount not to exceed $\$ 17,420.00$; fifteen percent ( $15 \%$ ) of the total contract value, due to the Project's tight completion schedule and staff's capability to respond swiftly to unanticipated construction conditions to limit potential claims or risk to the City.

NOW, THEREFORE, the City Council of the City of Milpitas hereby finds, determines, and resolves as follows:

1. The City Council has considered the full record before it, which may include but is not limited to such things as the staff report, testimony by staff and the public, and other materials and evidence submitted or provided to it. Furthermore, the recitals set forth above are found to be true and correct and are incorporated herein by reference.
2. The City Council hereby approves the Project Plans and Specifications.
3. The City Council hereby awards the construction contract to and authorizes the Interim City Manager to execute the contract and related documents with the lowest responsible bidder submitting a responsive bid, Chrisp Company, in the amount of $\$ 116,130.00$ for the Project.
4. The Director of Engineering/City Engineer is hereby authorized to negotiate and execute contract change order(s) in an aggregate amount not to exceed \$17,420.00 for the Project.
